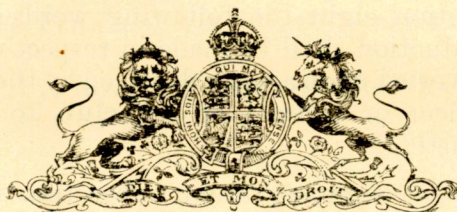

EXPLANATORY NOTE.

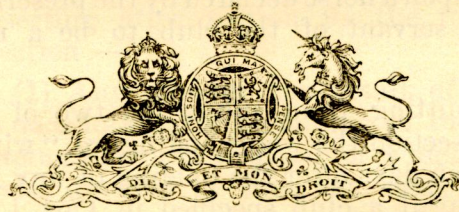
THE objects of this Bill are :—

To alter the incidence of the commission to be paid by clubs out of moneys paid into the totalizator ; to exempt moneys invested upon non-starters from liability to commission ; to provide for payment to the Colonial Treasurer of unclaimed investments, and for recovery of amounts due to the Crown ; and to confer on the Governor the power to make rules regulating the management of totalizators and payment of dividends.

This PUBLIC BILL originated in the LEGISLATIVE ASSEMBLY, and, having this day passed, is now ready for presentation to the LEGISLATIVE COUNCIL for its concurrence.
