Act No. 19, 1927.

An Act to amend the Totalizator Act, 1916, the Totalizator (Amendment) Act, 1919, the Totalizator (Amendment) Act, 1920, and certain other Acts in certain respects; and for purposes connected therewith. [Assented to, 28th February, 1927.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :--

1. (1) This Act may be cited as the "Totalizator short title. (Amendment) Act, 1927," and shall be read with the Totalizator Act, 1916, as amended by subsequent Acts. In this Act that Act as so amended is referred to as the Principal Act,

(2) This Act shall commence on a date to be appointed by the Governor and notified by proclamation published in the Gazette.

2. The Principal Act is amended as follows :-

(a) by inserting at the end of subsection one of section eight the following words:—" but no deduction shall be made in respect of amounts invested upon a horse declared by the prescribed officer or servant of the club to be a nonstarter";



EXPLANATORY NOTE.

THE objects of this Bill are :--

To alter the incidence of the commission to be paid by clubs out of moneys paid into the totalizator; to exempt moneys invested upon non-starters from liability to commission; to provide for payment to the Colonial Treasurer of unclaimed investments, and for recovery of amounts due to the Crown; and to confer on the Governor the power to make rules regulating the management of totalizators and payment of dividends.
