An Act to vest certain land vested in the Chief Minister by the Centenary Celebration Act (51 Victoria Number 9), in the Waverley Municipal Council for the purposes of a roadway; to amend the said Act; and for purposes connected therewith. [Assented to, 23rd December, 1929.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Centenary Cele-Short title. bration (Amendment) Act, 1929," and shall be read and construed with the Centenary Celebration Act (Act 51 Victoria Number 9).
