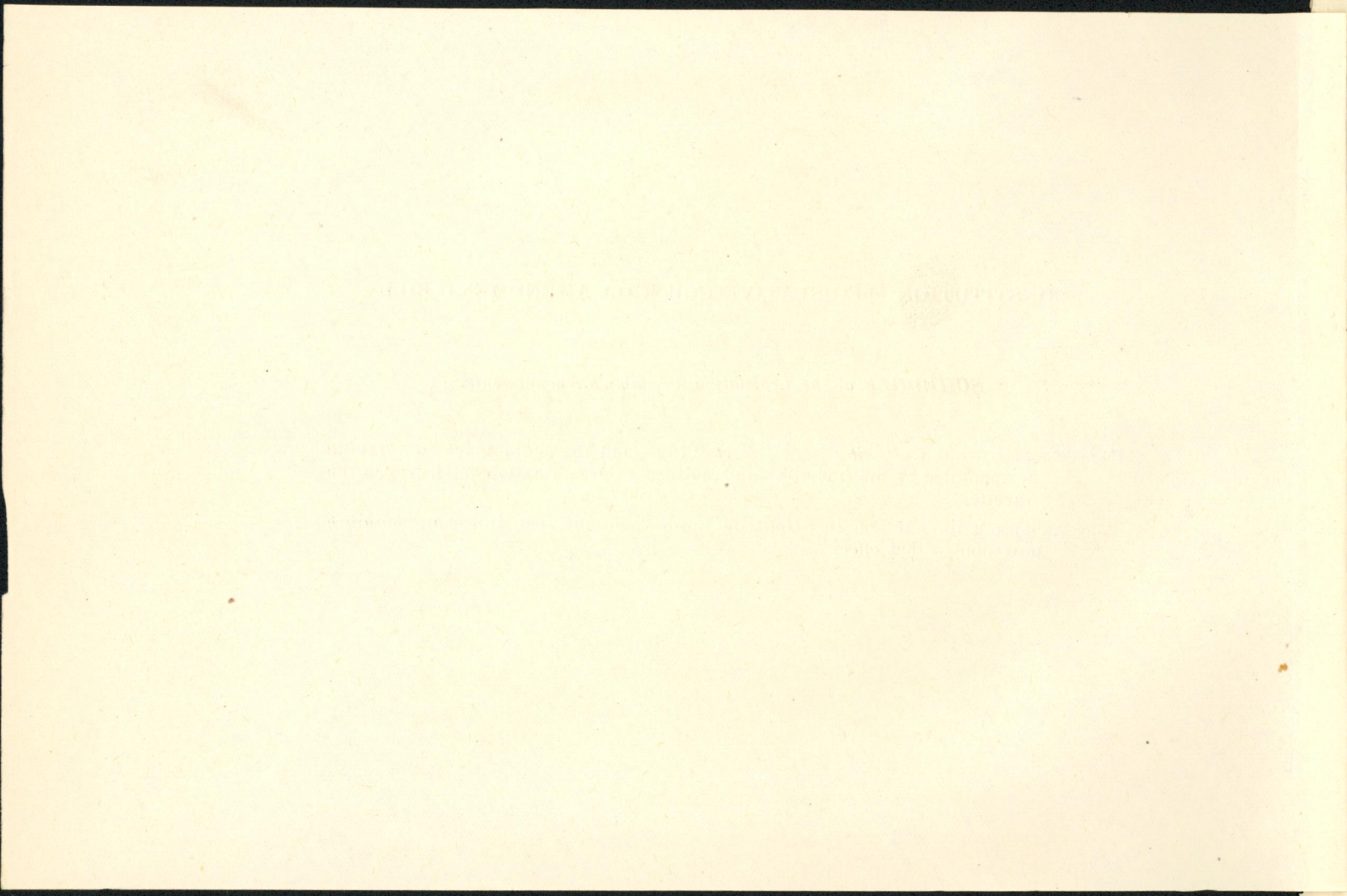


CONSTITUTION (LEGISLATIVE COUNCIL) AMENDMENT BILL.

SCHEDULE of the Legislative Assembly's Amendments.

Page 1, clause 1, line 7. *Omit* "1928" *insert* "**1929, and shall commence on a date to be appointed by the Governor and notified by proclamation published in the Gazette.**"

Page 2, clause 2, lines 15 and 16. *Omit* the words "and any such Bill shall contain a provision to that effect"

Act No. , 1929.

An Act to provide that the Legislative Council shall not be abolished nor certain provisions with respect to its constitution or powers be altered until a bill for the purpose has been approved by the electors on a referendum; to amend the Constitution Act, 1902, and certain other Acts; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Constitution Short title.
(Legislative Council) Amendment Act, 1928: 1929," and shall

Such day shall be appointed by the Legislature.

(4) When the Bill is submitted to the electors the vote shall be taken in such manner as the Legislature prescribes.

(5) If a majority of the electors voting approve the Bill, it shall be presented to the Governor for His Majesty's assent.

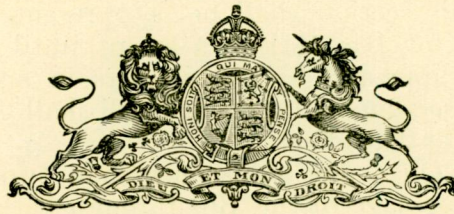
