An Act to validate the title of a certain Homestead Farm. [Assented to, 12th December, 1927.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Crown Lands short title.

(Homestead Farm) Validation Act, 1927."

(2) This Act shall be deemed to have commenced on the fourteenth day of June, one thousand nine

hundred and twenty-seven.
