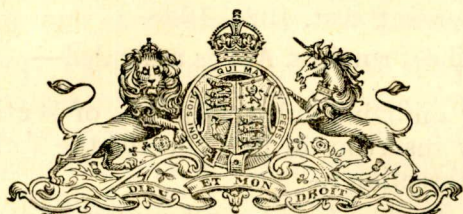

### **Act No. 45, 1928.**

An Act to amend the Electrical Contractors and Electricians Licensing Act, 1924, and certain other Acts in certain respects; to repeal the Electrical Contractors and Electricians Licensing (Amendment) Act, 1927, and the Electrical Contractors and Electricians Licensing (Amendment) Act, 1928; and for purposes connected therewith. [Assented to, 29th December, 1928.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** (1) This Act may be cited as the “Electrical Contractors and Electricians Licensing (Further Amendment) Act, 1928,” and shall be read with the Electrical Contractors Short title.

- (d) One member who shall be a licensed electrical contractor appointed by the Governor for a term of three years to represent the electrical contractors licensed under this Act.
- (e) One member who shall be a licensed electrician appointed by the Governor for a term of three years to represent the electricians licensed under this Act.

(5D) Electrical contractors' and electricians' licenses shall be interchangeable at the discretion of the board.

An additional fee to be prescribed shall be paid upon the granting to an electrician of an electrical contractor's license.

- (iv) by inserting after subsection six of the same section the following new subsection:—

(6A) A license as an electrical contractor shall not be issued to any person under the age of twenty-one years.

- (v) by inserting after subsection thirteen of the same section the following new subsection:—

(13A) The board may in its discretion grant a provisional license to an applicant for examination which shall hold good for the period stated therein, such period to be approximately sufficient to allow for the holding of the examination and for the communication of the result thereof to the applicant.

Any such provisional license shall be returned to the board immediately upon expiration, and shall not be renewable.

- (a) A person shall not undertake or carry out any electrical installation work unless he is licensed under this Act, or unless he is in the employment of and carries out such work under the personal supervision of a person so licensed.
- (b) An electrical contractor undertaking any electrical installation work, if he does not himself carry out the work, with or without assistance, shall constantly employ on the work until it is completed at least one person licensed under this Act.

When the work is carried out under the personal supervision of a person licensed under this Act, and consists of fixing, connecting, and maintaining overhead electrical conductors not in conduits, or of other work usually carried out by a linesman, this paragraph shall not extend to such work.

- (c) The holder of an electrician's license shall not undertake or carry out any electrical installation work save as the employee of an electrical contractor :

But this provision shall not apply where a licensed electrician undertakes or carries out electrical installation work on his own premises.
