An Act to make further provision with regard to the endowment payable to mothers under the Family Endowment Act, 1927-1928; to amend that Act and certain other Acts; and for purposes connected therewith. [Assented to, 23rd December, 1929.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** (1) This Act may be cited as the "Family Short title, Endowment (Further Amendment) Act, 1929," and shall be read and construed with the Family Endowment Act, 1927-1928, in this Act referred to as the Principal Act.

4. As from the commencement of this Act the endowment payable thereafter in respect of each claim granted before such commencement shall be reduced by the sum of five shillings per week save in the case of endowment payable in respect of a child under the age of fourteen years who is an inmate of a charitable institution.

Where a claim for endowment has been lodged before the commencement of this Act and is granted after such commencement, the amount of endowment payable thereunder in respect of any period prior to such commencement shall be calculated as if this Act had not been passed.

5. The Principal Act is further amended as follows:—

- (a) (i) by inserting at the end of subsection one of section 40A the words: “In the event of the absence, incapacity, or suspension of the Commissioner any of his powers, duties, and functions may be exercised and performed during such absence, incapacity, or suspension by the Assistant Commissioner or by an Acting Commissioner, appointed in pursuance of the provisions of the Income Tax (Management) Act, 1928”;
