Act No. 46, 1927.

An Act to provide for the removal of human remains and certain slabs and tombstones from a portion of the Church of England Cemetery at St. Peters; for the reinterment of such remains, and the re-erection of such slabs and tombstones elsewhere; and for purposes connected therewith. [Assented to, 9th December, 1927.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows.—

1. This Act may be cited as the "St. Peters Church of England Cemetery Act, 1927." Short title.

St. Peters Church of England Cemetery.

Removal of
remains.

2. (1) The council of the municipality of St. Peters may cause the remains of all persons buried in the land described in the Schedule to this Act, which it is proposed to resume for street widening purposes and which forms part of the Church of England Cemetery at St. Peters (so far as such remains can by reasonable diligence be discovered or identified), together with all slabs and tombstones in relation thereto, to be collected with due care and removed to another part of the Church of England Cemetery at St. Peters or to the Rookwood Cemetery or Bunnerong Cemetery, or some other cemetery agreed upon with the representatives of the said persons so buried, and shall there cause such remains to be reverently reinterred and such slabs or tombstones to be re-erected.

Council to
pay cost.

(2) The said council shall pay the cost of such removal, reinterment, and re-erection.

Compensation
not payable.

3. No compensation shall be payable by the said council to any person in respect of the performance of any act authorised by this Act.

SCHEDULE.

ALL that piece or parcel of land situate lying and being in the municipality of St. Peters, parish of Petersham, county of Cumberland, and State of New South Wales, containing by admeasurement 1 rood $2\frac{1}{4}$ perches : Commencing at a point on the north-western side of King-street distant 159 feet 9 inches north-easterly from the intersection of the north-western side of King-street aforesaid with the north-eastern side of Silver-street and bounded on the south-west by a line bearing 320 degrees 14 minutes for 31 feet $8\frac{1}{2}$ inches thence on the west by lines successively bearing 57 degrees 43 minutes for 4 feet $7\frac{3}{4}$ inches 51 degrees 24 minutes for 139 feet $7\frac{1}{2}$ inches 47 degrees 55 minutes for 202 feet $1\frac{1}{2}$ inches and 49 degrees 20 minutes for 2 feet $10\frac{1}{4}$ inches thence on the north-east by a line bearing 139 degrees 49 minutes for 35 feet 6 inches to the north-western side of King-street aforesaid thence on the south-east by part of the north-western side of King-street aforesaid being lines successively bearing 226 degrees 3 minutes 30 seconds for 35 feet $2\frac{1}{2}$ inches 229 degrees 38 minutes for 162 feet 3 inches 230 degrees 31 minutes 30 seconds for 59 feet $3\frac{3}{4}$ inches and 232 degrees 4 minutes for 92 feet $7\frac{3}{4}$ inches to the point of commencement be the said area and several dimensions all a little more or less.

St. Peters Church of England Cemetery.

2. ALL that piece or parcel of land situate lying and being in the municipality of St. Peters, parish of Petersham, county of Cumberland, and State of New South Wales, containing by admeasurement 1 rood 25 $2\frac{1}{4}$ perches : Commencing at a point on the north-western side of King-street distant 159 feet 9 inches north-easterly from the intersection of the north-western side of King-street aforesaid with the north-eastern side of Silver-street and bounded on the south-west by a line bearing 320 degrees 14 minutes for 31 feet 8 $\frac{1}{2}$ inches thence on the west by 30 lines successively bearing 57 degrees 43 minutes for 4 feet 7 $\frac{1}{2}$ inches 30 51 degrees 24 minutes for 139 feet 7 $\frac{1}{2}$ inches 47 degrees 55 minutes for 202 feet 1 $\frac{1}{2}$ inches and 49 degrees 20 minutes for 2 feet 10 $\frac{1}{4}$ inches thence on the north-east by a line bearing 139 degrees 49 minutes for 35 feet 6 inches to the north-western side of King-street aforesaid 25 thence on the south-east by part of the north-western side of King-street aforesaid being lines successively bearing 226 degrees 3 minutes 30 seconds for 35 feet 2 $\frac{1}{2}$ inches 229 degrees 38 minutes for 162 feet 3 inches 230 degrees 31 minutes 30 seconds for 59 feet 3 $\frac{1}{4}$ inches and 232 degrees 4 minutes for 92 feet 7 $\frac{1}{2}$ inches to the point of commence- 40 ment be the said area and several dimensions all a little more or less.
