

Act No. 24, 1928.

An Act to apply certain sums out of the Consolidated Revenue Fund towards the Services of the Year 1928-1929, and out of the General Loan Account for Services to be hereafter provided for by Loan. [Assented to, 2nd October, 1928.]

**W**HEREAS we Your Majesty's most dutiful and Preamble.  
loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of Seven millions seven hundred and forty-six thousand four hundred pounds, that is to say—

Out of the Consolidated Revenue Fund, the sum of  
Five millions five hundred and thirty-two  
thousand pounds, being the sum required to  
defray

**2.** Notwithstanding the provisions of the Audit Act, 1902, there shall and may be issued out of the General Loan Account and applied for or towards making good the Supply so resolved to be granted to His Majesty, the sum of Two millions two hundred and fourteen thousand four hundred pounds for the Services specified in Schedule A hereto annexed.

**3.** The Treasurer shall issue and pay the said sums for the Services aforesaid in such manner and in such proportions as the Governor, by Warrants or Orders in writing under his hand, and directed to the said Treasurer, shall from time to time order and direct. And the payments so to be made shall be charged upon and paid out of the Consolidated Revenue Fund and the General Loan Account respectively.
