
Sydney Corporation (Amendment) Bill, 1929,

EXPLANATORY MEMORANDUM.

THE Bill contains provisions-

- (a) Extending the Civic Commissioners' term of office to 30th June, 1930;
- (b) authorising the holding, in June, 1930, of an election of aldermen to constitute the Sydney Muncipal Council to take office on 1st July, 1930, and the compilation of the necessary lists and rolls;
- (c) providing for the election of the Lord Mayor;
- (d) amending the definition of "owner" and of the qualifications of owners and lessees;
- (e) the redistribution of the City into five wards in place of the existing thirteen wards;
- (f) permitting persons to vote by post who do not reside within the city or who by reason of illness or infirmity will be precluded from attending at a polling booth to vote;
- (g) providing that by-laws made by the Council shall be laid before Parliament, and that Parliament shall be empowered to disallow any such by-law;
- (h) empowering the Council to sell steam raised at its generating stations and not required for the purpose of generating electricity;
- (i) making clear the power of the Council to resume land outside the city for electric lighting purposes;
- (j) dedicating Rowe-street as a public way and empowering the Council to recover the cost of construction of such way from adjoining owners;
- (k) empowering the Council where a way has been realigned to permit of minor repairs and improvements being made in buildings standing on the old alignment;
- (1) empowering the Council to approve of plans for the alteration of existing buildings in the city which do not comply with the requirements of the City of Sydney Improvement Act where the Council is satisfied that such compliance is reasonably practicable;
- (m) confirming a number of financial adjustments between the Government and the Council, including the lighting of the Domain, the payment of the Metropolitan Health Officer, &c., the maintenance, &c., of Pyrmont Bridge, and the cost of the regulation of traffic in the city, and the vesting of a certain part of the old Woolloomooloo Fish Market site in the Council;
- (n) modifying a certain realignment of the eastern side of George-street between Goulburn and Campbell streets.

Provision has been made in the Bill also for a number of necessary minor and consequential amendments.



This Public Bill originated in the Legislative Assembly, and, having this day passed, is now ready for presentation to the Legislative Council for its concurrence.

An Act to extend the period during which the Sydney Corporation (Commissioners) Act, 1927, is to remain in force; to provide for the election of aldermen of the City of Sydney; to provide for the dedication of Rowe-street as a public way, and for the repayment to the Municipal Council of Sydney of certain expenses incurred in the construction and completion thereof; to enlarge the powers of the said Council in certain respects; to provide for certain financial adjustments between the Government and

the said Council; to vest certain land in the said Council; to amend the realignment of part of the eastern side of George-street, between Goulburn and Campbell streets; to validate certain matters; to amend the Sydney Corporation (Commissioners) Act, 1927, and the Sydney Corporation Act, 1902, and certain other Acts; and for purposes connected therewith.

DE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5 the same, as follows:—
