## Women's College (Lands) Bill, 1929.

#### EXPLANATORY MEMORANDUM.


THIS is a Bill to vest a property known as The Maples in the University upon trust to subgrant it to the Women's College upon the same trusts, &c., as those on which the main Women's College property is held.

The Maples was acquired by the College and added to and renovated for the accommodation of students.

Difficulties arose as to whether the expenditure was such as was contemplated by the Women's College Endowment Act, 1916, and it was finally arranged with the College that the property should be vested in the University upon trust to subgrant it to the College upon the same trusts and subject to the same restrictions as affect the main College property within the University.

In anticipation of this arrangement being carried into effect a sum of £4,000 was paid to the College in June last in lieu of any further sums payable under the Women's College Endowment Act, 1916. The Bill validates this payment and repeals the Act in question.


