- (b) by omitting from subsection two of section three the words "one thousand nine hundred and thirty-two" and by inserting in lieu thereof the words "one thousand nine hundred and thirty-three";

(c) by omitting from subsection one of section four the words "one thousand nine hundred and thirty-one" and by inserting in lieu thereof the words "one thousand nine hundred and thirty-two."


