Where the said amount exceeds ten shillings such period shall be one day for each ten shillings of such amount or part thereof.

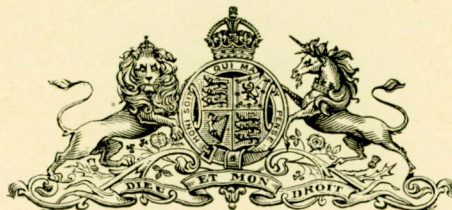

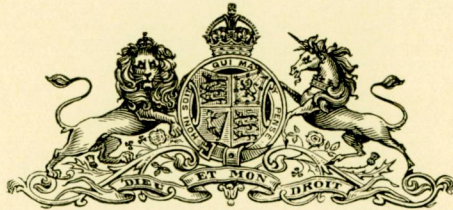
