Act No. 24, 1931.

An Act to extend the period during which the Public Service (Salaries Reduction) Act, 1930, is to remain in force; for that purpose to amend the said Act; and for purposes connected therewith. [Assented to, 3rd July, 1931.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Public Service Short title. (Salaries Reduction) Amendment Act, 1931," and shall be deemed to commence on the thirtieth day of June, one thousand nine hundred and thirty-one.
