Act No. 40, 1931.

An Act to provide for the revesting of certain land in the parish of Gordon resumed under the Public Works Act, 1912, for the purpose of a State Forest at Pymble; and for purposes connected therewith. [Assented to, 2nd October, 1931.]

WHEREAS by a notification of resumption published in the Gazette of the sixteenth day of October, one thousand nine hundred and twenty-five, the land described in the said notification of resumption (whereof the land described in the Schedule to this Act forms part) was, in pursuance of section fifteen of the Forestry-Act, 1916, resumed under the Public Works Act, 1912, for the purpose of a State Forest at Pymble. And whereas by a Proclamation of the Governor made in pursuance of the provisions of the Forestry Act, 1916, and published in the Gazette on the twenty-first day

day of May, one thousand nine hundred and twenty-six, the said land described in the said Schedule to this Act was with other land declared to be dedicated as a State Forest. And whereas it has been found that the said land described in the Schedule to this Act is not required for the purpose for which it was resumed and dedicated as aforesaid, and it is desired to revest the same in the persons who were entitled thereto at the time of the said resumption: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Pymble State

Forest Partial Revesting Act, 1931."

Revesting.

2. On the passing of this Act the land described in the Schedule to this Act shall revest in the persons who were entitled thereto at the time of such resumption as aforesaid for such estates and interests and with and subject to such rights as were subsisting in respect of the said land at the time of such resumption as aforesaid, and such land shall be subject to all trusts, obligations, estates, interests, contracts, charges, rates, rights-of-way or other easements from which it was freed and discharged by such resumption as if the said land had not been resumed, and shall also be subject to any interests in or equities binding on the compensation moneys created since the said resumption, but shall be free from the dedication effected or expressed to be effected by the Proclamation aforesaid.

ALL that piece or parcel of land situate in the parish of Gordon, County of Cumberland, containing 29 acres 1 rood 27 perches, being the whole of the land comprised in Certificate of Title dated the 15th July, 1905, registered volume 1621, folio 87.
