

Reduction of Rents.

(2) In this section "trustee" includes legal representative of a deceased person, committee of the estate of an insane person, manager of the estate of an incapable person, the Master in Lunacy, the Master in 5 Equity, director of a company, and any other person acting in any fiduciary capacity.

9. (1) The Governor may make regulations not Regulations. inconsistent with this Act prescribing all matters which by this Act are required or permitted to be prescribed, 10 or which are necessary or convenient to be prescribed, in order to give effect to this Act.

Without limiting the generality of the foregoing provisions of this section the regulations may prescribe the forms to be used and the fees to be paid in con15 nection with applications to the court under this Act.

(2) The regulations shall---

(a) be published in the Gazette;

(b) take effect from the date of publication, or from such later date as is specified in the regulations;

(c) be laid before both Houses of Parliament within fourteen sitting days after the publication thereof, if Parliament is then in session, and if not, then within fourteen sitting days after the commencement of the next session.

25 after the commencement of the next session.

(3) If either House of Parliament passes a resolution of which notice has been given at any time within fifteen sitting days after such regulations have been laid before such House disallowing any regulation or part 30 thereof, such regulation or part shall thereupon cease to have effect.

10. The provisions of this Act shall cease to have Duration of effect upon the thirty-first day of December, one Act. thousand nine hundred and thirty-two.
