An Act to validate certain guarantees given to certain banks by the Colonial Treasurer or pursuant to minutes of the Governor and Executive Council; to authorise the Colonial Treasurer to execute guarantees in certain cases; to make certain contingent appropriations out of the Consolidated Revenue Fund; to amend the Usury, Bills of Lading, and Written Memoranda Act, 1902; and for purposes connected therewith. [Assented to, 31st December, 1934.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Government short title. Guarantees Act, 1934."

2. (1) The action of the Governor and Executive Validation. Council or the Colonial Treasurer in authorising the giving of the guarantees set out in the Schedule to this Act



Provided always that no co-surety, cocontractor, or co-debtor shall be entitled to recover from any other co-surety, co-contractor, or co-debtor by the means aforesaid more than the just proportion to which as between those parties themselves such last-mentioned person shall be justly liable.

(b) by omitting from section twelve the words "ten sec. 12 or eleven" and by inserting in lieu thereof the (Revision). words "or ten."
