Act No. 60, 1934.

An Act to provide for the vesting of certain parcels of land situate at Lewisham in the trustees of the religious order of women known as the Little Company of Mary and in the trustees of the Roman Catholic Church and School and Cemetery lands respectively; to provide for the vesting of land upon the appointment of new trustees of the said religious order; to validate certain matters; and for purposes connected therewith. [Assented to, 31st December, 1934.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Lewisham Hospital and Church Lands Act, 1934." Short title.

Lewisham Hospital and Church Lands.

Vesting of
hospital
lands.

2. (1) The land described in the First Schedule to this Act is hereby vested in Norah Martin, Elizabeth O'Connor, Annie McMahon and Josephine Hazledine, the present trustees for the Province of Australasia of the religious order of women known as the Little Company of Mary (in this Act hereinafter referred to as the "Little Company of Mary") for an estate in fee simple as joint tenants, subject to a right of foot way over the land described in the Second Schedule to this Act, as appurtenant to the lands respectively described in the Third Schedule and the Fourth Schedule to this Act.

(2) The land described in the First Schedule to this Act shall be held upon trust for the Little Company of Mary for the Province of Australasia under and in accordance with the constitutions for the time being of the Little Company of Mary, but subject nevertheless to the provisions of this Act.

3. (1) The Provincial Council of the Little Company of Mary for the Province of Australasia shall have power to appoint from time to time a new trustee to fill any vacancy which may occur in the office of a trustee of the land described in the First Schedule to this Act.

(2) Upon any appointment of a trustee made under subsection one of this section the property and estate in the lands described in the First Schedule to this Act shall without any conveyance vest in the persons who after such appointment are the trustees, as joint tenants, and shall be held by them upon the trusts set out in subsection two of section two of this Act.

Evidence.

(3) A certificate purporting to be signed by the Mother Provincial for the time being of the Little Company of Mary for the Province of Australasia stating that the persons named therein were at the date specified the trustees of the land described in the First Schedule to this Act shall in favour of a purchaser or mortgagee or the Registrar-General be conclusive evidence of the facts stated.

(4) For the purposes of section four of this Act and of subsections one, two and three of this section the land described in the First Schedule to this Act shall be deemed

deemed to include any land in the parish of Petersham, county of Cumberland, acquired in conjunction with the land described as aforesaid by the trustees for the time being of such last-mentioned land, and held by the trustees upon the trusts set out in subsection two of section two of this Act.

4. The trustees of the Little Company of Mary for the Province of Australasia shall have power to sell or mortgage the lands described in the First Schedule to this Act or any part thereof, but such lands shall not be sold or mortgaged without the consent in writing of the Roman Catholic Archbishop of Sydney for the time being.

Sale or mortgage of land in First Schedule.

Where the consent referred to in this section is given, then, in favour of a purchaser or mortgagee or the Registrar-General, such consent shall be conclusive evidence that any permission or approval required under the constitutions of the Little Company of Mary has been duly obtained.

5. The land described in the Third Schedule to this Act, together with a right of foot way over the land described in the Second Schedule to this Act, is hereby vested in the Most Reverend Michael Kelly, of Sydney, Roman Catholic Archbishop, the Most Reverend Michael Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, subject to a certain indenture of mortgage to the Commonwealth Bank of Australia dated the fourth day of December, one thousand nine hundred and twenty-two, and registered in the General Registry of Deeds at Sydney, Number 751, Book 1286, and shall be held by them upon trust as a site for a Roman Catholic church, school and clergyman's residence, and for any other church purpose approved of by the Roman Catholic Archbishop of Sydney for the time being.

Vesting of Church lands.

6. (1) The land described in the Fourth Schedule to this Act, together with a right of foot way over the land described in the Second Schedule to this Act, is hereby vested in the Most Reverend Michael Kelly, of Sydney, Roman Catholic Archbishop, the Most Reverend Michael

Lewisham Hospital and Church Lands.

Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, and shall be held by them upon trust as a site for a cemetery, or for any church purpose approved by the Roman Catholic Archbishop of Sydney for the time being.

(2) Nothing in this Act shall impair or in any way restrict the powers conferred on the trustees for the time being of the Lewisham Roman Catholic Cemetery by the Lewisham Cemetery Act, 1925. The powers conferred by that Act may be exercised by the trustees for the time being of the land described in the Fourth Schedule to this Act.

Sale or mortgage of land in Third and Fourth Schedules.

7. The trustees for the time being of the lands respectively described in the Third and Fourth Schedules to this Act shall have power to sell or mortgage the respective lands so described or any part thereof; but such lands shall not be sold or mortgaged without the consent in writing of the Roman Catholic Archbishop of Sydney for the time being.

Validation of dedication.

8. The dedication of a public highway purporting to have been effected by a certain deed of dedication dated the twelfth day of June, one thousand nine hundred and twenty-eight, and registered in the General Registry of Deeds at Sydney No. 729, Book 1520, is hereby validated.

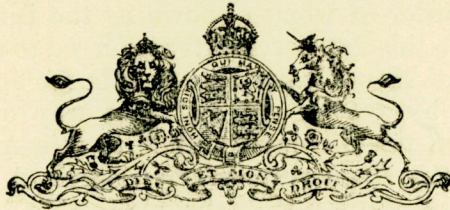

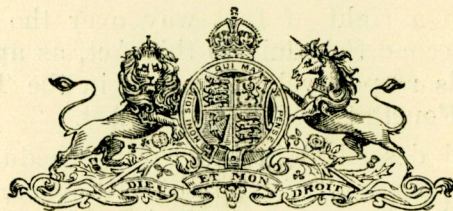

Act No. , 1934.

An Act to provide for the vesting of certain parcels of land situate at Lewisham in the trustees of the religious order of women known as the Little Company of Mary and in the trustees of the Roman Catholic Church and School and Cemetery lands respectively; to provide for the vesting of land upon the appointment of new trustees of the said religious order; to validate certain matters; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Lewisham Hospital and Church Lands Act, 1934."

Lewisham Hospital and Church Lands.

2. (1) The land described in the First Schedule to this Act is hereby vested in Norah Martin, Elizabeth O'Connor, Annie McMahon and Josephine Hazledine, the present trustees for the Province of Australasia of the religious order of women known as the Little Company of Mary (in this Act hereinafter referred to as the "Little Company of Mary") for an estate in fee simple as joint tenants, subject to a right of foot way over the land described in the Second Schedule to this Act, as appurtenant to the lands respectively described in the Third Schedule and the Fourth Schedule to this Act.

Vesting of hospital lands.

(2) The land described in the First Schedule to this Act shall be held upon trust for the Little Company of Mary for the Province of Australasia under and in accordance with the constitutions for the time being of the Little Company of Mary, but subject nevertheless to the provisions of this Act.

3. (1) The Provincial Council of the Little Company of Mary for the Province of Australasia shall have power to appoint from time to time a new trustee to fill any vacancy which may occur in the office of a trustee of the land described in the First Schedule to this Act.

Trustees of hospital lands.

(2) Upon any appointment of a trustee made under subsection one of this section the property and estate in the lands described in the First Schedule to this Act shall without any conveyance vest in the persons who after such appointment are the trustees, as joint tenants, and shall be held by them upon the trusts set out in subsection two of section two of this Act.

Vesting in new trustees.

30 (3) A certificate purporting to be signed by the Mother Provincial for the time being of the Little Company of Mary for the Province of Australasia stating that the persons named therein were at the date specified the trustees of the land described in the First Schedule to this Act shall in favour of a purchaser or mortgagee or the Registrar-General be conclusive evidence of the facts stated.

Evidence.

(4) For the purposes of section four of this Act and of subsections one, two and three of this section the land described in the First Schedule to this Act shall be deemed

deemed to include any land in the parish of Petersham, county of Cumberland, acquired in conjunction with the land described as aforesaid by the trustees for the time being of such last-mentioned land, and held by the trustees upon the trusts set out in subsection two of section two of this Act.

4. The trustees of the Little Company of Mary for the Province of Australasia shall have power to sell or mortgage the lands described in the First Schedule to this Act or any part thereof, but such lands shall not be sold or mortgaged without the consent in writing of the Roman Catholic Archbishop of Sydney for the time being.

Sale or mortgage of land in First Schedule.

Where the consent referred to in this section is given, then, in favour of a purchaser or mortgagee or the Registrar-General, such consent shall be conclusive evidence that any permission or approval required under the constitutions of the Little Company of Mary has been duly obtained.

5. The land described in the Third Schedule to this Act, together with a right of foot way over the land described in the Second Schedule to this Act, is hereby vested in the Most Reverend Michael Kelly, of Sydney, Roman Catholic Archbishop, the Most Reverend Michael Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, subject to a certain indenture of mortgage to the Commonwealth Bank of Australia dated the fourth day of December, one thousand nine hundred and twenty-two, and registered in the General Registry of Deeds at Sydney, Number 751, Book 1286, and shall be held by them upon trust as a site for a Roman Catholic church, school and clergyman's residence, and for any other church purpose approved of by the Roman Catholic Archbishop of Sydney for the time being.

Vesting of Church lands.

6. (1) The land described in the Fourth Schedule to this Act, together with a right of foot way over the land described in the Second Schedule to this Act, is hereby vested in the Most Reverend Michael Kelly, of Sydney, Roman Catholic Archbishop, the Most Reverend Michael Sheehan,

Vesting of cemetery lands.

Lewisham Hospital and Church Lands.

Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, and shall be held by them upon trust as a site for a cemetery, or for any church purpose approved by the Roman Catholic Archbishop of Sydney for the time being.

(2) Nothing in this Act shall impair or in any way restrict the powers conferred on the trustees for the time being of the Lewisham Roman Catholic Cemetery by the Lewisham Cemetery Act, 1925. The powers conferred by that Act may be exercised by the trustees for the time being of the land described in the Fourth Schedule to this Act.

7. The trustees for the time being of the lands respectively described in the Third and Fourth Schedules to this Act shall have power to sell or mortgage the respective lands so described or any part thereof; but such lands shall not be sold or mortgaged without the consent in writing of the Roman Catholic Archbishop of Sydney for the time being.

8. The dedication of a public highway purporting to have been effected by a certain deed of dedication dated the twelfth day of June, one thousand nine hundred and twenty-eight, and registered in the General Registry of Deeds at Sydney No. 729, Book 1520, is hereby validated.

I. This Act may be cited as the "Lewisham Hospital and Church Lands Act, 1934."

2 The words "Lewisham Hospital and Church Lands" shall mean the lands and premises specified in the Schedule to this Act.

3 The words "the Board" shall mean the Lewisham Hospital and Church Lands Board established by the King's Most Excellent Majesty in pursuance of the Statute in that behalf made.

4 The Board shall have the same powers and authorities as are conferred on the Board of Trustees of the Lewisham Hospital by the Statute in that behalf made.

5 The Board shall have power to borrow money and to incur liabilities for the purposes of this Act.

6 The Board shall have power to acquire and hold land and premises for the purposes of this Act.

7 The Board shall have power to sell or otherwise dispose of any land or premises held by it for the purposes of this Act.

8 The Board shall have power to do all such things as may be necessary or expedient for the purposes of this Act.

9 The Board shall be subject to the control and supervision of the Minister of Health.

10 The Board shall have power to make regulations for the better carrying out of the purposes of this Act.

11 The Board shall have power to sue and be sued, and to take legal proceedings, in its own name.

12 The Board shall have power to enter into contracts and to incur liabilities in its own name.

13 The Board shall have power to employ and dismiss persons in its own name.

14 The Board shall have power to pay salaries and allowances to its members and officers.

15 The Board shall have power to pay interest on any money borrowed by it.

16 The Board shall have power to pay any other expenses incurred by it in the execution of its duties.

17 The Board shall have power to do all such things as may be necessary or expedient for the purposes of this Act.

18 The Board shall have power to do all such things as may be necessary or expedient for the purposes of this Act.

A BILL

To provide for the vesting of certain parcels of land situate at Lewisham in the trustees of the religious order of women known as the Little Company of Mary and in the trustees of the Roman Catholic Church and School and Cemetery lands respectively; to provide for the vesting of land upon the appointment of new trustees of the said religious order; to validate certain matters; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Lewisham Hospital and Church Lands Act, 1934." Short title.

Vesting of

2. (1) The land described in the First Schedule to this Act is hereby vested in Norah Martin, Elizabeth O'Connor, Annie McMahon and Josephine Hazledine, the present trustees for the Province of Australasia of the religious order of women known as the Little Company of Mary (in this Act hereinafter referred to as the "Little Company of Mary") for an estate in fee simple as joint tenants, subject to a right of foot way over the land described in the Second Schedule to this Act, as appurtenant to the lands respectively described in the Third Schedule and the Fourth Schedule to this Act. 5 10

(2) The land described in the First Schedule to this Act shall be held upon trust for the Little Company of Mary for the Province of Australasia under and in accordance with the constitutions for the time being of the Little Company of Mary, but subject nevertheless to the provisions of this Act. 15

3. (1) The Provincial Council of the Little Company of Mary for the Province of Australasia shall have power to appoint from time to time a new trustee to fill any vacancy which may occur in the office of a trustee of the land described in the First Schedule to this Act. 20

(2) Upon any appointment of a trustee made under subsection one of this section the property and estate in the lands described in the First Schedule to this Act shall without any conveyance vest in the persons who after such appointment are the trustees, as joint tenants, and shall be held by them upon the trusts set out in subsection two of section two of this Act. 25

(3) A certificate purporting to be signed by the Mother Provincial for the time being of the Little Company of Mary for the Province of Australasia stating that the persons named therein were at the date specified the trustees of the land described in the First Schedule to this Act shall in favour of a purchaser or mortgagee or the Registrar-General be conclusive evidence of the facts stated. 30 35

(4) For the purposes of section four of this Act and of subsections one, two and three of this section the land described in the First Schedule to this Act shall be deemed 40
deemed

deemed to include any land in the parish of Petersham, county of Cumberland, acquired in conjunction with the land described as aforesaid by the trustees for the time being of such last-mentioned land, and held by the trustees upon the trusts set out in subsection two of section two of this Act.

4. The trustees of the Little Company of Mary for the Province of Australasia shall have power to sell or mortgage the lands described in the First Schedule to this Act or any part thereof, but such lands shall not be sold or mortgaged without the consent in writing of the Roman Catholic Archbishop of Sydney for the time being.

Sale or mortgage of land in First Schedule.

Where the consent referred to in this section is given, then, in favour of a purchaser or mortgagee or the Registrar-General, such consent shall be conclusive evidence that any permission or approval required under the constitutions of the Little Company of Mary has been duly obtained.

5. The land described in the Third Schedule to this Act, together with a right of foot way over the land described in the Second Schedule to this Act, is hereby vested in the Most Reverend Michael Kelly, of Sydney, Roman Catholic Archbishop, the Most Reverend Michael Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, subject to a certain indenture of mortgage to the Commonwealth Bank of Australia dated the fourth day of December, one thousand nine hundred and twenty-two, and registered in the General Registry of Deeds at Sydney, Number 751, Book 1286, and shall be held by them upon trust as a site for a Roman Catholic church, school and clergyman's residence, and for any other church purpose approved of by the Roman Catholic Archbishop of Sydney for the time being.

Sheehan, of Homebush, Co-adjutor Archbishop, the Right Reverend Monsignor Patrick Lewis Coonan, of Forest Lodge, Vicar General, and the Very Reverend Thomas Phelan, of Lewisham, Chancellor, for an estate in fee simple as joint tenants, and shall be held by them upon trust as a site for a cemetery, or for any church purpose approved by the Roman Catholic Archbishop of Sydney for the time being. 5

(2) Nothing in this Act shall impair or in any way restrict the powers conferred on the trustees for the time being of the Lewisham Roman Catholic Cemetery by the Lewisham Cemetery Act, 1925. Sale or mortgage of land in Third and Fourth Schedules.
