An Act to provide for the appointment and for the term of office of the Commissioner of Police, and for the method of removing him from office; to provide for the appointment of a Deputy Commissioner of Police and for the definition of his powers, authorities, duties, and functions; to amend the Police Regulation Act, 1899, the Police Regulation (Superannuation) Act, 1906, and certain other Acts in certain respects; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5the same, as follows:—

(c) absents himself from duty for a period of fourteen consecutive days except on leave granted by the Governor, unless such absence is occasioned by illness or other unavoidable cause;

(d) becomes an insane person or patient or an incapable person within the meaning of the Lunacy Act of 1898;

(e) resigns his office by writing under his hand addressed to the Governor.
