Act No. 14, 1932.

An Act to extend the period during which the Public Service Salaries Act (No. 2), 1931, is to remain in force; for that purpose to amend the said Act; and for purposes connected therewith. [Assented to, 30th June, 1932.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Public Service Salaries (Amendment) Act, 1932." Short title and citation.

(2) The Public Service Salaries Act (No. 2), 1931, as amended by this Act, may be cited as the Public Service Salaries Act, 1931-1932.
