An Act to provide for the removal of human remains and certain slabs and tombstones from land at Stockton; for the reinterment of such remains, and the re-erection of such slabs and tombstones in the general cemetery at Stockton; and for purposes connected therewith. [Assented to, 10th October, 1933.]

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :---

1. This Act may be cited as the "Stockton Cemetery short title. Act, 1933."

Commissioner for Main Roads to remove remains, etc., and reinter in Stockton General Cemetery.

2. (1) The Commissioner for Main Roads, appointed under the Transport (Division of Functions) Act, 1932, may cause the remains of all persons buried in the lands described in the Schedule to this Act (so far as such remains can by reasonable diligence be discovered or identified), together with all slabs and tombstones in relation thereto, to be collected with due care and removed to the general cemetery at Stockton, and shall cause such remains to be reverently reinterred and such slabs or tombstones to be re-erected.

(2) The Commissioner for Main Roads shall pay the cost of such removal, reinterment, and re-erection.

No compensation payable. 3. No compensation shall be payable by the Commissioner for Main Roads to any person in respect of the performance of any act authorised by this Act.

EXPLANATORY MEMORANDUM.

The object of this Bill is to authorise the Commissioner for Main Roads to remove certain human remains which are found to have been buried in land required for a deviation of Main Road No. 108, to give access to a new vehicular ferry dock at Stockton, and to have these remains reinterred in the Stockton General Cemetery.

The land required is partly Crown land and partly private land. It has never been set apart for a cemetery, but was used as a burial ground many years ago. A headstone on one of the few graves affected records that the burial took place in 1861.

The removal will be at the cost of the Commissioner for Main Roads, but no compensation in respect of the removal will be paid.
