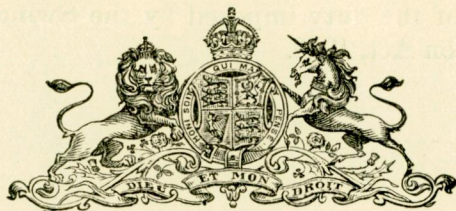

Act No. 9, 1935.

An Act to impose a stamp duty on certain records required to be kept under the Swine Compensation Act, 1928-1935, in lieu of that imposed by the Swine Compensation Taxation Act, 1928; and for purposes connected therewith. [Assented to, 6th March, 1935.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Swine Compensation Taxation Act, 1935," and shall be read and construed with the Swine Compensation Act, 1928-1935. Short title.

(2) This Act shall commence on the first day of March, one thousand nine hundred and thirty-five.

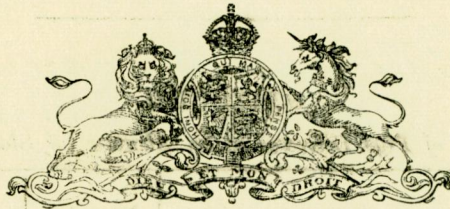
