## Act No. 2, 1934.

An Act to provide for the further postponement of the triennial elections of aldermen directed by the Sydney Corporation Act, 1932, to be held in the year one thousand nine hundred and thirty-three; to extend the term of office of the aldermen of the City of Sydney at present holding office; to amend the Sydney Corporation Act, 1932, and certain other Acts; and for purposes connected therewith. [Assented to, 29th June, 1934.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**1.** (1) This Act may be cited as the "Sydney Corporation (Elections) Act, 1934," and shall be read and construed with the Sydney Corporation Act, 1932, as amended by subsequent Acts.

**2.** (1) The triennial election of aldermen of the City of Sydney directed by section nineteen of the Sydney Corporation Act, 1932, to be held on the first day of December, one thousand nine hundred and thirty-three, and postponed by the Sydney Corporation (Amendment) Act, 1933, is hereby further postponed until the first Monday in December, one thousand nine hundred and thirty-four.

(2) The aldermen of the City of Sydney in office at the commencement of this Act may, subject to the provisions of the Sydney Corporation Act, 1932, as amended by subsequent Acts, including this Act, remain in office until the election of aldermen on the first Monday in December, one thousand nine hundred and thirty-four, is held, and shall then retire from office, but may at such election be re-elected if otherwise qualified.

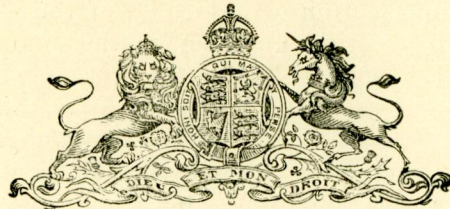
