Act No. , 1936.

An Act to modify the operation of the Public Service Salaries Act, 1931-1936; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Public Service Salaries (Further Amendment) Act, 1936." Short title.

(2) The Public Service Salaries Act, 1931-1936, as amended by this Act, may be cited as the Public Service Salaries Acts, 1931-1936.

Public Service Salaries (Further Amendment.)

2. The Public Service Salaries Act, 1931-1936, is amended by inserting next after section four the following new section:—

4A. Where pursuant to section four of this Act a deduction is required to be made from the salary of an officer, then, as from the first day of December, one thousand nine hundred and thirty-six, the amount of the deduction which, but for this section, would have been applicable in respect of the salary of such officer, shall be reduced by fifty per centum.

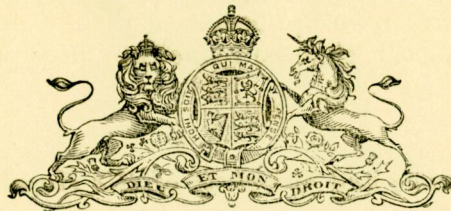

Act No. 52, 1936.

An Act to modify the operation of the Public Service Salaries Act, 1931-1936; and for purposes connected therewith. [Assented to, 9th December, 1936.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Public Service Short title. Salariēs (Further Amendment) Act, 1936."

(2) The Public Service Salaries Act, 1931-1936, as amended by this Act, may be cited as the Public Service Salaries Acts, 1931-1936.
