

An Act to authorise the Rural Bank of New South Wales to make advances through its Government Agency Department to persons purchasing land under certain Closer Settlement Schemes; for this purpose to amend the Government Savings Bank Act, 1906, and certain other Acts; and for purposes connected therewith.

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5 the same, as follows :--

(ii) by inserting next after the same paragraph the following new paragraph :---

> (c) in the case of the Closer Settlement Agency—the day upon which the Rural Bank (Agency) Amendment Act, 1936, commences.
