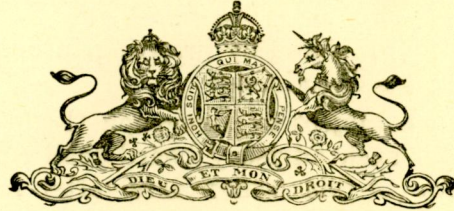

## Act No. 32, 1939.

An Act to alter the constitution of Closer Settlement Advisory Boards; for this purpose to amend the Closer Settlement (Amendment) Act, 1907, as amended by subsequent Acts; and for purposes connected therewith. [Assented to, 7th November, 1939.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Closer Settlement (Amendment) Act, 1939."

**2.** The Closer Settlement (Amendment) Act, 1907, as amended by subsequent Acts, is amended by omitting from section two all words after the words "as an 'Advisory Board'" and by inserting in lieu thereof the following new subsections—

(2) (a) Subject to paragraph (b) of this subsection each such advisory board shall consist of two members (in this section hereinafter referred to as "appointed members") to be appointed by the Governor, one of whom shall be so appointed to be the chairman of the board.

(b) For the purpose of dealing with such matters, questions, or inquiries as the Minister may, from time to time, direct, either generally or in any particular case or class of cases, each such board shall consist of three members, of whom two shall be the appointed members and one shall be a district surveyor nominated, either generally or in any particular case or class of cases, by the Minister.

(3) In case of the absence or illness of an appointed member the Governor may appoint a deputy, who, during such absence or illness, shall have and may exercise and discharge all the powers, authorities, duties and functions of an appointed member.

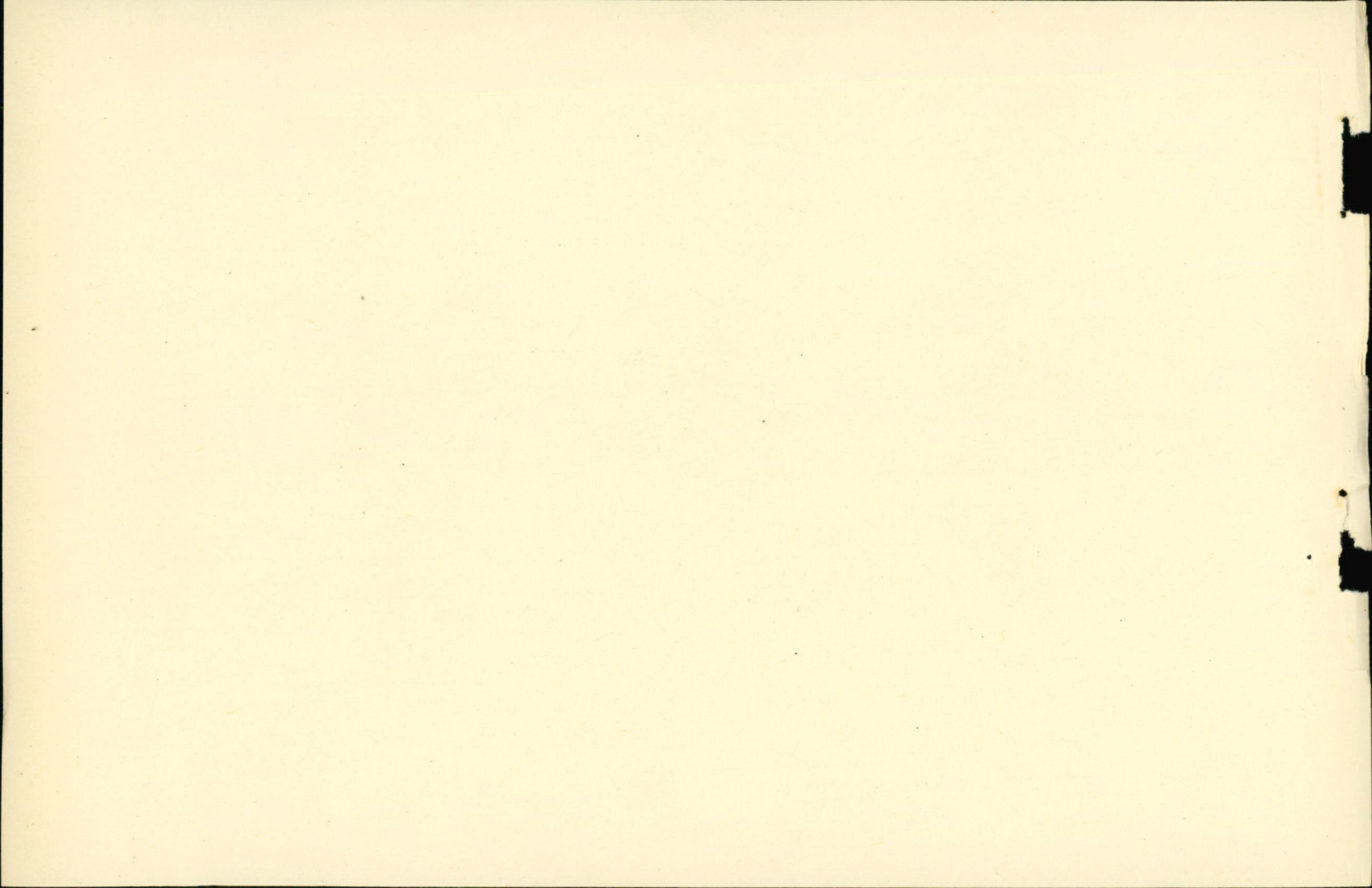

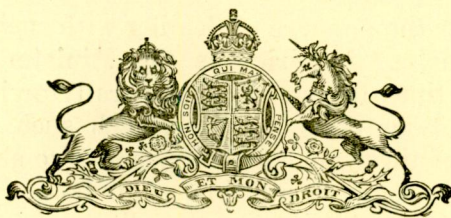

Act No. , 1939.

An Act to alter the constitution of Closer Settlement Advisory Boards; for this purpose to amend the Closer Settlement (Amendment) Act, 1907, as amended by subsequent Acts; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5 the same, as follows:—

1. (1) This Act may be cited as the "Closer Settlement (Amendment) Act, 1939."

10 (2) (a) Subject to paragraph (b) of this subsection each such advisory board shall consist of two members (in this section hereinafter referred to as "appointed members") to be appointed by the Governor, one of whom shall be so appointed to be the

(b) For the purpose of dealing with such matters, questions, or inquiries as the Minister may, from time to time, direct, either generally or in any particular case or class of cases, each such board  
20 shall consist of three members, of whom two shall be the appointed members and one shall be a district surveyor nominated, either generally or in any particular case or class of cases, by the Minister.
