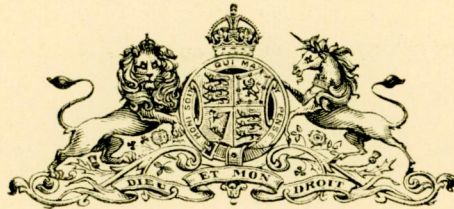

### EXPLANATORY NOTE.

**THE** Bill amends subsection three of section two of the Government Relief Administration Act, 1930, by providing that in the administration of that Act, the Under Secretary of the Department of Labour and Industry and Social Services shall be the permanent head within the meaning of the Public Service Act, 1902, and any Act amending the same.

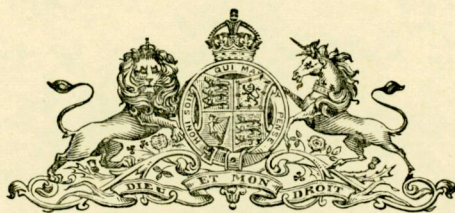

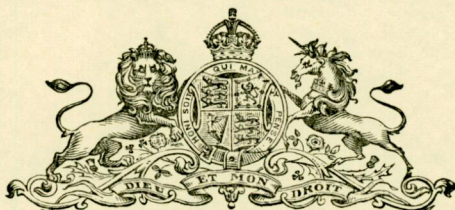

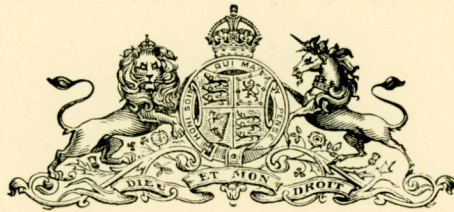
