Act No. 6, 1938.

An Act to amend the Local Government Act, 1919, in certain respects; to validate certain matters; and for purposes connected therewith. [Assented to, 27th September, 1938.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Local Government (Amendment) Act, 1938." Short title.

Local Government (Amendment).

Amendment of Act No. 41, 1919. **2.** (1) The Local Government Act, 1919, as amended by subsequent Acts, is amended—

Sec. 177 (4). (Approval of certain ordinary loans.) (a) by omitting from subsection four of section one hundred and seventy-seven the word “thirty-eight” and by inserting in lieu thereof the word “thirty-nine”;

Sec. 400A (13). (Loans and Advances Advisory Committee.) (b) by omitting from subsection thirteen of section 400A the word “thirty-eight” and by inserting in lieu thereof the word “thirty-nine”;

Sec. 422B (5). (Agreement by Treasurer in relation to certain franchises.) (c) by omitting from subsection five of section 422B the word “thirty-eight” and by inserting in lieu thereof the word “thirty-nine”;

Sec. 493A (4). (Agreement by Treasurer—loan liabilities.) (d) by omitting from subsection four of section 493A the words “June, one thousand nine hundred and thirty-eight” and by inserting in lieu thereof the words “September, one thousand nine hundred and thirty-nine.”

(2) Subsection one of this section shall be deemed to have commenced on the first day of July, one thousand nine hundred and thirty-eight.

Further amendment of Act No. 41, 1919. **3.** (1) The Local Government Act, 1919, as amended by subsequent Acts, is further amended—

Sec. 422B (3). (Moneys provided by Parliament.) (a) by omitting from subsection three of section 422B the words “may be paid out of the Consolidated Revenue Fund without further appropriation than this Act” and by inserting in lieu thereof the words “shall be paid out of moneys provided by Parliament”;

Sec. 493A. (Certain agreements by Treasurer.) (b) (i) by inserting in subsection one of section 493A after the word “borrowing” where first occurring the words “or in respect of any loan or loans raised by a council for the purpose of repaying or renewing the whole or any part of the original loan or of any renewal loan in respect thereof”;

(ii)

Local Government (Amendment).

(ii) by inserting in subsection two of the same section after the word "year" where firstly occurring the words "during the term of the loan or of any loan or loans raised by the Council for the purpose of repaying or renewing the whole or any part of such loan or of any renewal loan in respect thereof."

(2) Paragraph (b) of subsection one of this section shall be deemed to have commenced on the sixteenth day of December, one thousand nine hundred and thirty-five.

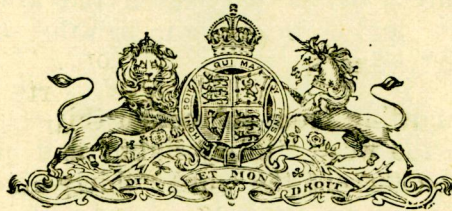
