## Act No. 1, 1938.

An Act to validate certain amendments of the rules of the Manchester Unity Independent Order of Oddfellows Friendly Society in New South Wales; and for purposes connected therewith. [Assented to, 4th August, 1938.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the "Manchester Unity Short title. Independent Order of Oddfellows Friendly Society (Rules Validation) Act, 1938," and shall be read and construed with the Friendly Societies Act, 1912-1935.
- 2. (1) The Manchester Unity Independent Order of Validation. Oddfellows Friendly Society in New South Wales is in this section referred to as "the society."

- (2) The amendments set out in the Schedule to this Act of the rules of the society as in force immediately before the fourth day of June one thousand nine hundred and thirty-eight shall be deemed for all purposes to have been lawfully made on the said fourth day of June, and to have been so made under and in accordance with the provisions of the rules of the society relating to the manner of making altering and rescinding rules.
- (3) As soon as practicable after the commencement of this Act, the Registrar shall register the amendments set out in the Schedule to this Act, and shall issue to the society an acknowledgment of registry of those amendments, and that acknowledgment shall be conclusive evidence that the amendments are duly registered.

The registration of such amendments under this subsection shall be deemed to be a registration of amendments of the rules of the society for all purposes of the Friendly Societies Act, 1912-1935.
