An Act to validate certain acts of the committees for the time being of the Southern Mines Rescue Station District and of the Western Mines Rescue Station District; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of

(2) This Act shall be read and construed with the Mines Rescue Act, 1925.

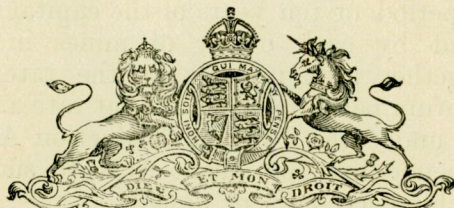
2. (1) The following acts of the committees for the time being of the Southern Mines Rescue Station District and of the Western Mines Rescue Station District are hereby validated:—

10 (a) the repayment by the committee for the time being of either such district by instalments over a period of ten years of the capital contribution paid by each owner of mines in its district together with interest at the rate of six per centum per annum (or at that rate as reduced by or under the Interest Reduction Act, 1931, as amended by subsequent Acts) to such owner or to his successors or assigns;
