The amount which constitutes the tax imposed upon motor vehicles by the Motor Vehicles (Taxation) Act, 1924, as amended by subsequent Acts, is hereby, with respect to the tax payable upon motor vehicles the registration or renewal of registration of which takes effect on or after a day to be appointed by the Governor and notified by proclamation published in the Gazette, increased by twelve and one-half per centum.
