An Act to authorise the Minister for Public Works to sell certain lands by public auction, public tender or private treaty; to amend the Public Works Act, 1912, as amended by subsequent Acts; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Public Works Short title.
(Sale of Wickham Lands) Act, 1940."

(2) This Act shall be read and construed with the Public Works Act, 1912, as amended by subsequent Acts.

Public Works (Sale of Wickham Lands).

2. (1) The Minister may sell by public auction, public tender or private treaty the lands described in the Schedule to this Act. Power of Minister to sell certain lands.

The purchase money arising from such sale shall be applied in such manner as the Governor may direct.

(2) Upon payment or tender to the Minister of the purchase money in respect of such sale the Minister shall convey the lands, for and on behalf of His Majesty, to the purchasers thereof by deed duly registered.

10 A deed so executed and registered shall be effectual to vest the lands comprised therein in the said purchaser for the estate so purchased by him.

(3) A receipt under the hand and seal of the Minister shall be a sufficient discharge to the purchaser of such lands for the purchase money in the receipt expressed to be received.

(4) This section shall not be construed so as to affect in any way any power of leasing which, under subsection three of section ninety-eight of the Public Works Act, 1912, as amended by subsequent Acts, is exercisable in respect of the lands described in the Schedule to this Act.

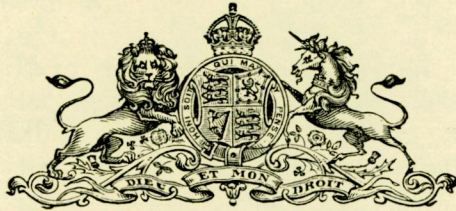

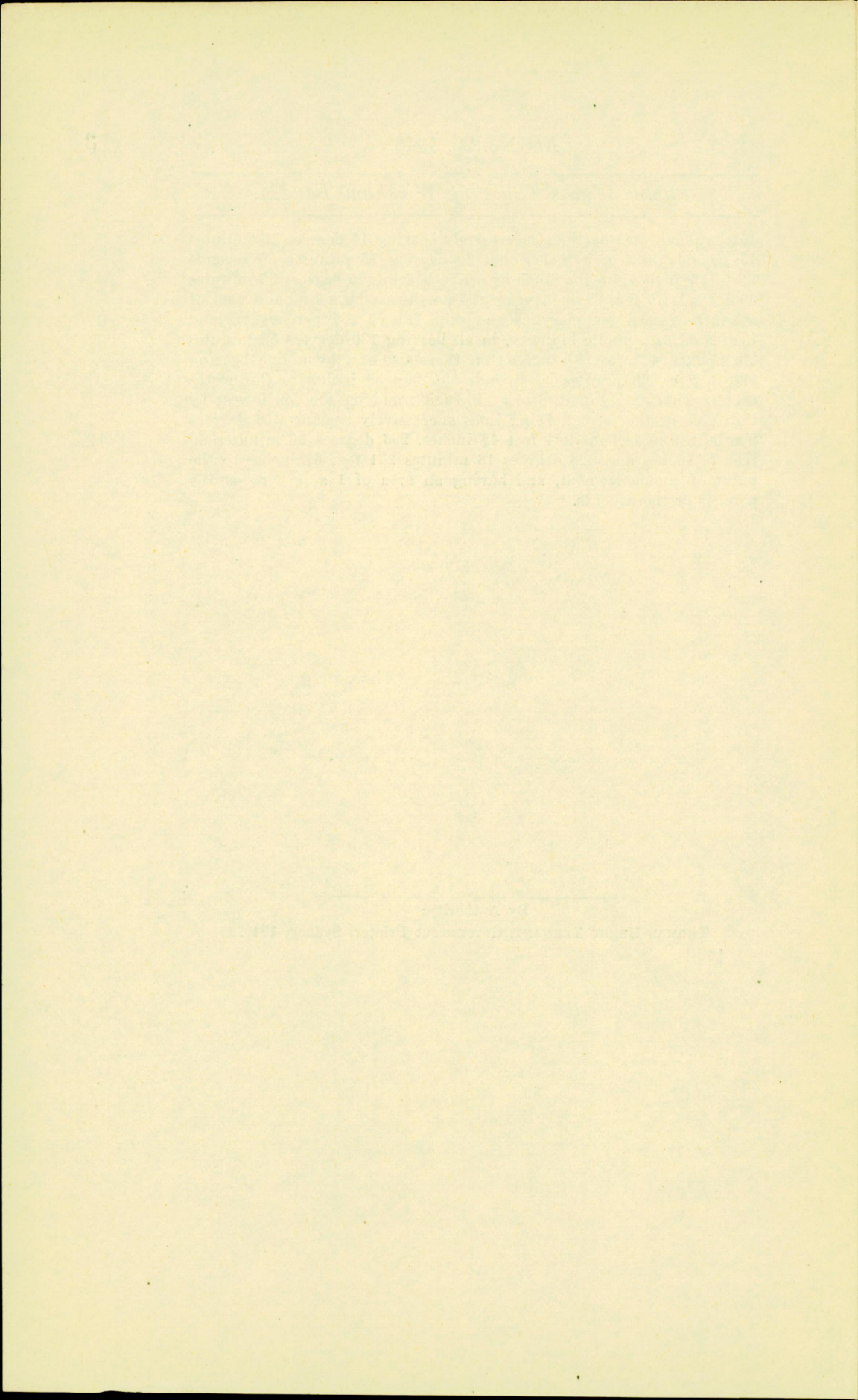
