## Act No. 8, 1938.

An Act to apply certain sums out of the Consolidated Revenue Fund, the Government Railways Fund, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, and the Sydney Harbour Trust Fund, towards the services of the Year 1938–1939. [Assented to, 6th October, 1938.]

WHEREAS we Your Majesty's most dutiful and Preamble. loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled,

have resolved to grant to your Majesty the sum of Six millions five hundred and twenty-two thousand three hundred pounds, that is to say—

- Out of the Newcastle and District Transport Trust General Fund, the sum of Forty-two thousand eight

Out of the Sydney Harbour Trust Fund, the sum of Sixty-six thousand six hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and thirtynine.

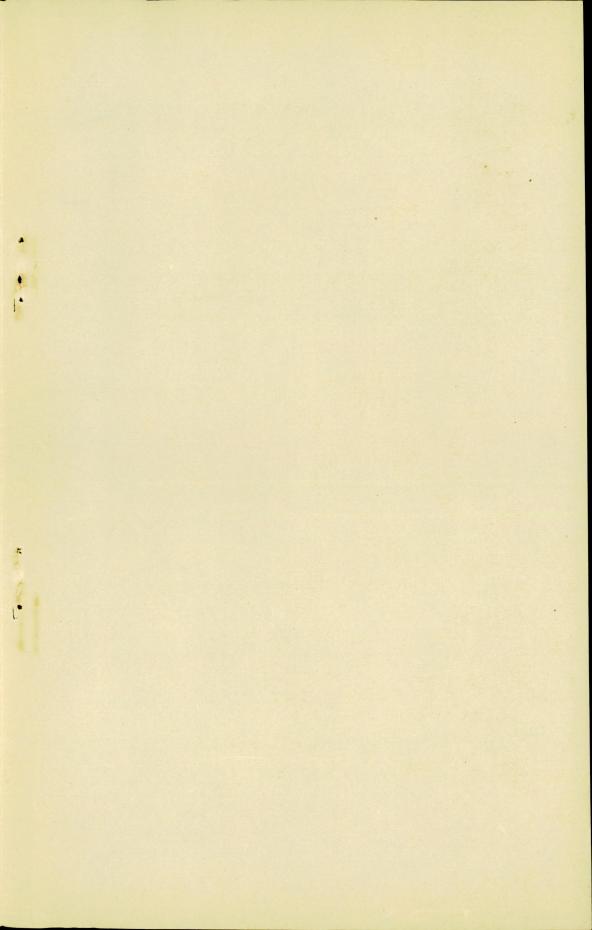

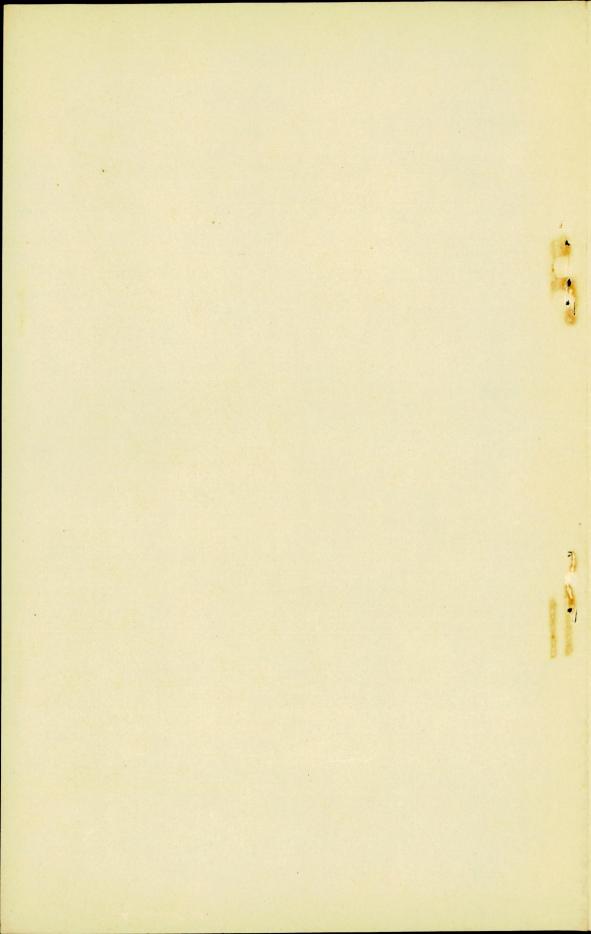
