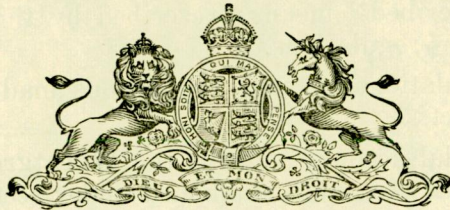

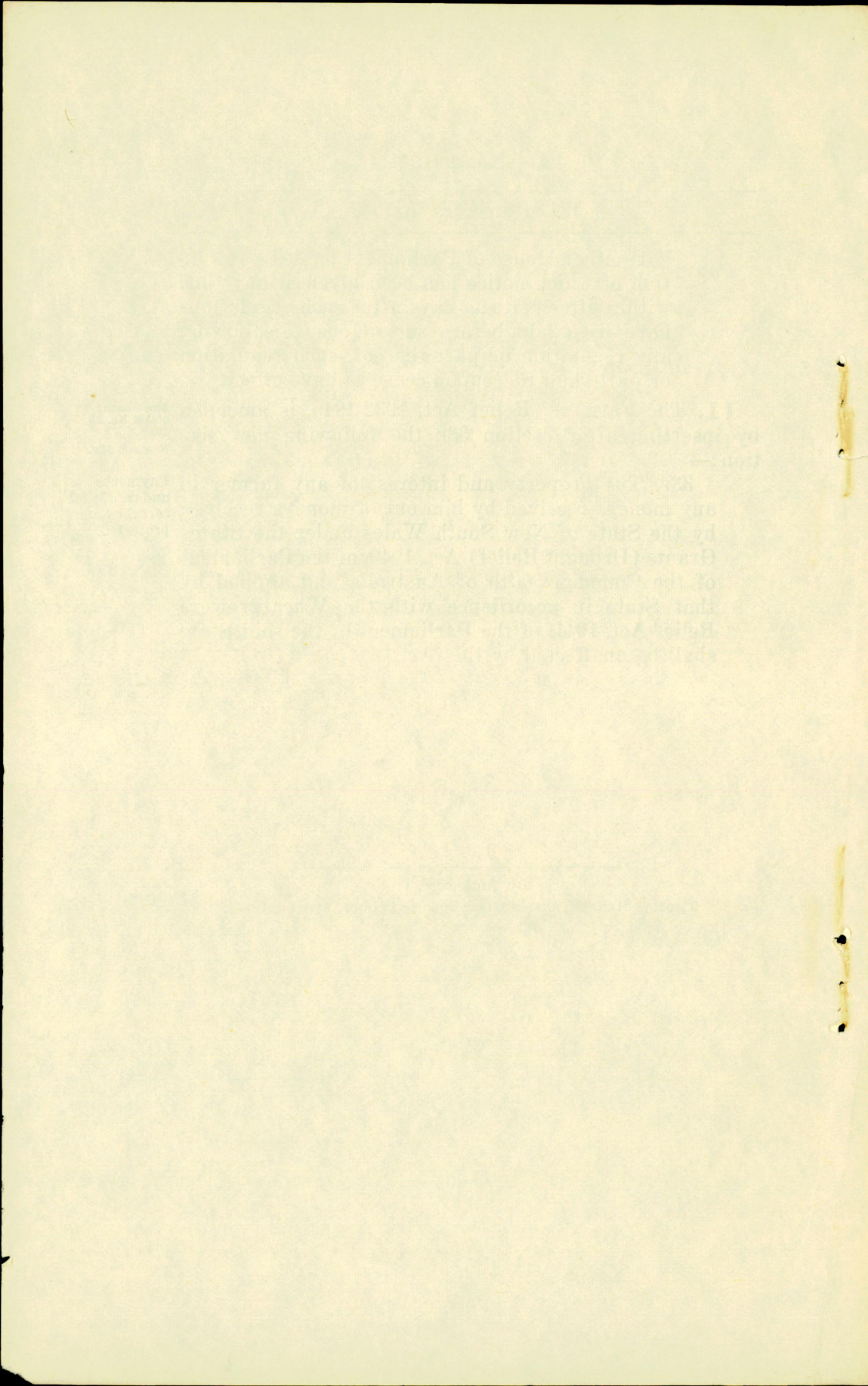

(2) Such regulations shall—

- (i) be published in the Gazette;
- (ii) take effect from the date of publication or from a later date to be specified therein;
- (iii) be laid before both Houses of Parliament within fourteen sitting days after publication if Parliament is in session and, if not, then within fourteen sitting days after the commencement of the next session.

If

Wheatgrowers Relief.

If either House of Parliament passes a resolution of which notice has been given at any time within fifteen sitting days after such regulations have been laid before such House disallowing any regulation or part thereof, such regulation or part shall thereupon cease to have effect.

11. The Farmers' Relief Act, 1932-1940, is amended by inserting after section 33e the following new section:—

33f. The property and interest of any farmer in any moneys received by him out of moneys received by the State of New South Wales under the States Grants (Drought Relief) Act, 1940, of the Parliament of the Commonwealth of Australia and applied by that State in accordance with the Wheatgrowers Relief Act, 1941, of the Parliament of the said State shall be unaffected by this Act.
