### Act No. 61, 1941.

An Act to prohibit the promotion of or the taking part in certain shooting matches or competitions wherein animals are released from captivity for the purpose of shooting; to amend the Prevention of Cruelty to Animals Act, 1901; and for purposes connected therewith.
