#### FINANCE.

# Electricity Development Bill, 1945.

# EXPLANATORY NOTE.

THE object of this Bill is to provide for the development of electricity supply within the State of New South Wales.

The Bill makes provision for the constitution of the Electricity Authority of New South Wales, consisting of seven members, and defines the powers, authorities, duties and functions of such Authority. These powers include power to promote and supervise the development, expansion and improvement of electricity supply throughout the State.

The Authority will also promote the use of the natural resources of the State in connection with the generation of electricity and the use of electricity for industrial and manufacturing purposes.

The Authority is empowered to grant subsidies and fix maximum prices for electricity supplied in bulk or by way of interchange. Electricity supply authorities will be required to make contributions towards defraying the expenses of carrying out the provisions of the Bill.

The Electricity Advisory Committee will be dissolved and the regulation of the sale and hiring of electrical appliances and apparatus and the licensing of electrical contractors and electricians will be exercised and controlled by the Authority.

The Bill also authorises the Minister for Public Works to provide and construct power stations and main transmission lines.

- (m) prescribing the furnishing of information, particulars, returns and statistics by electricity supply authorities and the time and mode of furnishing and the manner of verification of the same.

(3) A regulation made under this section may impose a penalty not exceeding fifty pounds for any breach thereof and also a daily penalty not exceeding ten pounds for any continuing breach thereof.

 25 standard rules recommended or adopted by the Standards Association of Australia relating to the matter with

which the regulation deals.

- (b) take effect from the date of publication or from a later date to be specified in the regulations; and
  - (c) be laid before both Houses of Parliament within fourteen sitting days after publication if Parliament is then in session, and if not, then within fourteen sitting days after the commencement of the next session.
