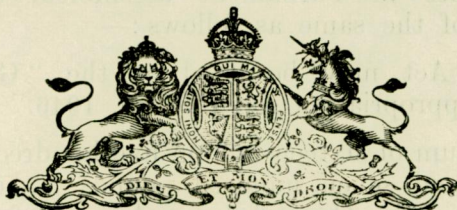

Act No. 49, 1946.

An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith. [Assented to, 24th December, 1946.]

WHEREAS the Australian Loan Council at its ^{Preamble.} sixtieth meeting held on the twenty-first day of August, one thousand nine hundred and forty-six decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for

for the loan programmes of the Commonwealth and the States for the financial year ending on the thirtieth day of June, one thousand nine hundred and forty-seven, shall be forty-five million two hundred and ninety-seven thousand pounds, and by unanimous decision allocated an amount of fourteen million seven hundred and twenty-six thousand pounds to the State of New South Wales, BE it enacted therefore by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

Short title. **1.** This Act may be cited as the "General Loan Account Appropriation Act (No. 2), 1946."

Appropriation from General Loan Account. **2.** The sum of sixteen million five hundred and eighty-four thousand seven hundred pounds is hereby appropriated from the General Loan Account for the public works and services hereunder set out, and shall, as required be applied as follows:—

Act No. , 1946.

An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith.

WHEREAS the Australian Loan Council at its Preamble. sixtieth meeting held on the twenty-first day of August, one thousand nine hundred and forty-six decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed

for the loan programmes of the Commonwealth and the States for the financial year ending on the thirtieth day of June, one thousand nine hundred and forty-seven, shall be forty-five million two hundred and ninety-seven thousand pounds, and by unanimous decision allocated an amount of fourteen million seven hundred and twenty-six thousand pounds to the State of New South Wales, BE it enacted therefore by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

1. This Act may be cited as the "General Loan Short title. Account Appropriation Act (No. 2), 1946."

2. The sum of sixteen million five hundred and eighty-four thousand seven hundred pounds is hereby appropriated from the General Loan Account for the public works and services hereunder set out, and shall, as required be applied as follows:—
