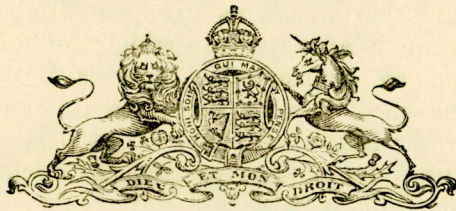

Act No. 37, 1944.

An Act to amend the Metropolitan Water, Sewerage, and Drainage Act, 1924-1943, in certain respects; and for purposes connected therewith. [Assented to, 8th December, 1944.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Metropolitan Water, Sewerage, and Drainage (Amendment) Act, 1944." Short title and citation.
