An Act to make further provision as to the transfer of registrations and licenses and the grant, renewal or cancellation of registrations for public vehicles; to regulate the hours of employment of certain drivers of taxi-cabs and private hire cars; for these and other purposes to amend the Transport Act, 1930-1943; the State Transport (Co-ordination) Act, 1931; and the Motor Traffic Act, 1909-1937; and for purposes connected therewith. BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title and citation

- 1. (1) This Act may be cited as the "Transport (Amendment) Act, 1945."
- (2) (a) The Transport Act, 1930, as amended by subsequent Acts, is in this Act referred to as the Principal Act.



EXPLANATORY NOTE.

THE Bill provides that, in relation to taxi-cabs and private hire cars in the Metropolitan and Newcastle Transport Districts, the Commissioner for Road Transport and Tramways—
