Act to make provision in relation to the An marketing of fish by co-operative trading societies and the constitution of co-operative advisory committees ; for these purposes to amend the Co-operation Act, 1923-1948, and the Fisheries and Oyster Farms Act, slugi1935, as amended by subsequent Acts; and for purposes connected therewith. [Assented to, 16th November, 1949.]

DE it enacted by the King's Most Excellent Majesty, B by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :---

1. (1) This Act may be cited as the "Co-operation Short title and (Amendment) Act, 1949".

(4) The Governor may, after a report and recommendation furnished to the Minister by the advisory council or advisory committee referred to in subsection two of this section, by notice in writing to a trading society—

(a) suspend for such period as he may determine or revoke any approval given

to such society pursuant to this section in respect of any market so established. controlled or operated by such society:

- (b) from time to time vary or amend the terms. conditions or stipulations imposed in granting his approval to the establishment, control or operation by such society of any market for the sale of fish.
