Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for the financial year ending on the thirtieth day of June, one thousand nine hundred and forty-nine, shall be sixty-nine million seven hundred and thirty-one thousand pounds, and by unanimous decision allocated an amount of sixteen million two hundred and eighty-three thousand pounds to the State of New South Wales, BE it enacted therefore by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows :—

**1.** This Act may be cited as the "General Loan Short title. Account Appropriation Act, 1948."
