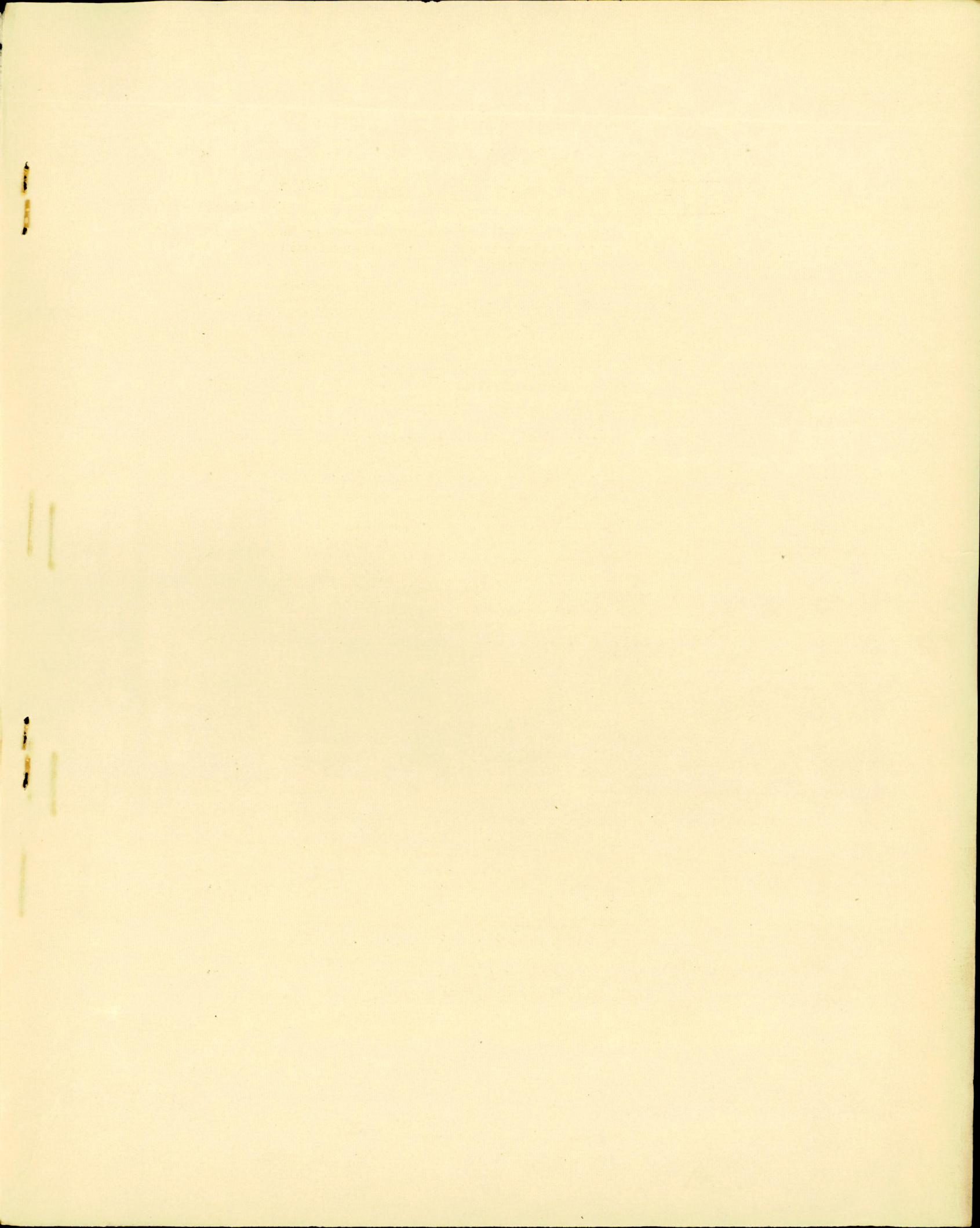

Hospital Benefits Agreement (Amendment) Bill, 1949.

EXPLANATORY NOTE.

THIS Bill ratifies an Agreement dated 16th June, 1949, between the Commonwealth of Australia and the State of New South Wales amending the original Agreement dated 1st July, 1946, between the Commonwealth and the State relating to hospital benefits.

The main provisions of the amending Agreement are—

- (a) to amend the definition of "public hospital" to exclude a public ward in a tuberculosis hospital;
- (b) to amend the definition of "qualified person" to clarify the position of persons entitled to workers' compensation benefits and similar cases in so far as hospital benefits are concerned;
- (c) to increase the benefit from non-public ward cases from 6s. to 8s. per day from 1st November, 1948;
- (d) to increase the benefit for public ward cases from 6s. to 8s. per day from 1st July, 1948;
- (e) to provide for reciprocal hospital benefits with other countries;
- (f) to delete from 1st July, 1948, clauses 7 and 8 of the original Agreement providing for the creation of a trust fund for capital expenditure on public hospitals—amounts already set aside up to the date mentioned to be used only for the purpose previously intended.

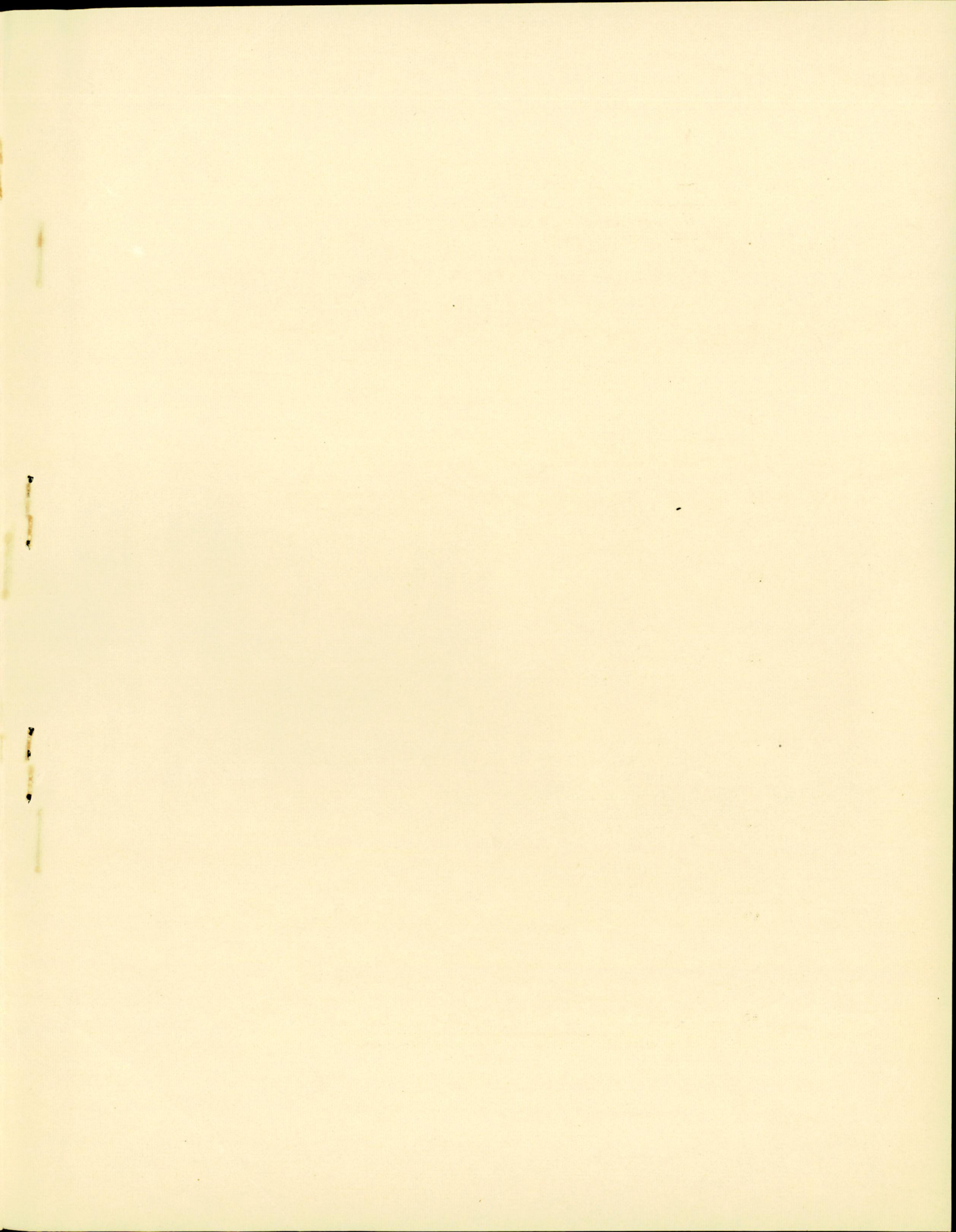

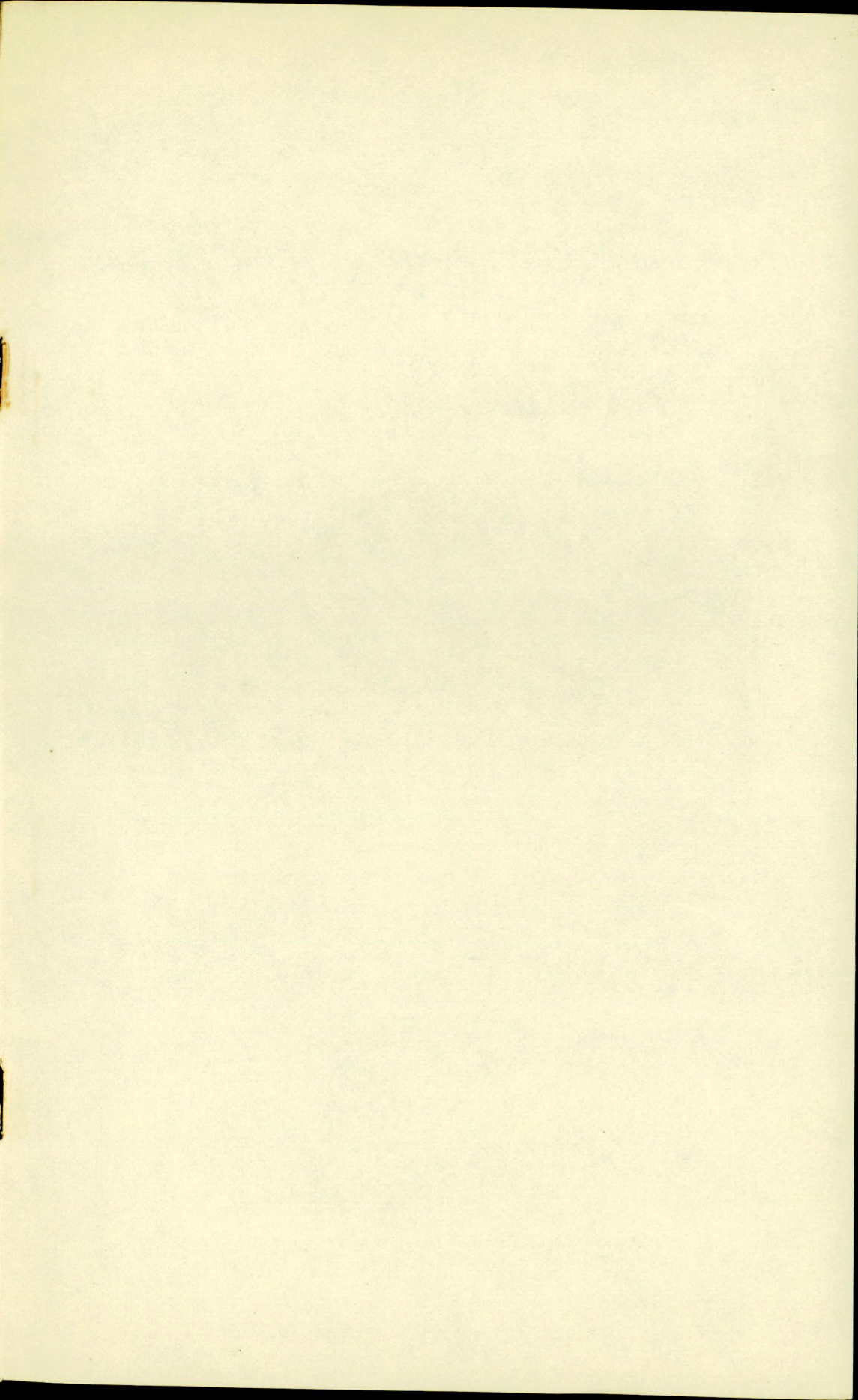
