Amendments of Public Works Act, 1912, for purposes of this Act.

- (h) by inserting next after section forty-six the following new section:—
 - 47. For the purposes of this Act, but not otherwise, the Public Works Act, 1912, as amended by subsequent Acts, is amended—
 - (a) by omitting from section eighty-one the words "Provided that no highway so dedicated shall exceed one chain in width";
 - (b) by omitting sections ninety-one and ninety-seven.
- (2) The Housing Act, 1912, as amended by subsequent Acts and by this Act, may be cited as the Housing Act, 1912-1947.

3. (1) The Housing Act, 1941, is amended by inserting next after section nineteen the following new section:—

Construction and disposal of temporary buildings by Commission. 19a. The Commission shall have power and shall be deemed always to have had power to construct buildings for emergency housing accommodation and upon such terms and conditions as it considers reasonable to sell or hire the same to any person legally possessed of land.

(2) The Housing Act, 1941, as amended by this Act, may be cited as the Housing Act, 1941-1947.
