An Act to amend the Kosciusko State Park Act, 1944, in certain respects; and for purposes connected therewith.

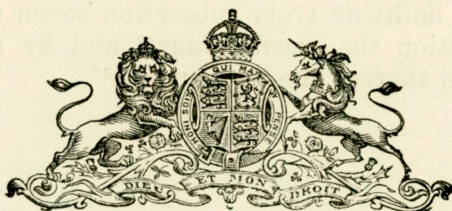
