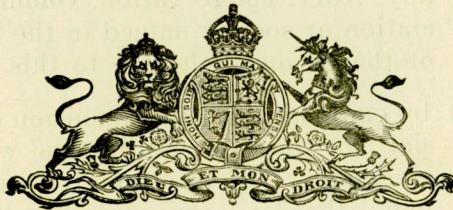

Act No. 2, 1948.

An Act to amend the Roman Catholic Church Communities' Lands Act, 1942-1943, in certain respects; and for purposes connected therewith. [Assented to, 22nd April, 1948.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Roman Catholic Church Communities' Lands (Amendment) Act, 1948." Short title and citation.

EXPLANATORY NOTE.

THE objects of this Bill are:—

- (i) to apply the provisions of the Roman Catholic Church Communities' Lands Act, 1942-1943, to certain additional orders, congregations, communities, associations and societies of the Roman Catholic Church;

- (iii) to place beyond doubt the power of a body corporate under the Act to authorise a servant or agent to operate on its bank account.

A BILL
