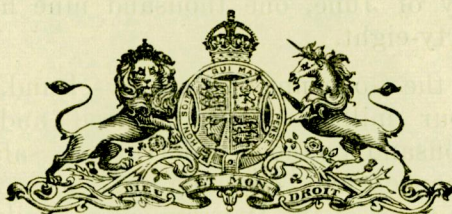

Act No. 16, 1947.

An Act to apply certain sums out of the Consolidated Revenue Fund, the Government Railways Fund, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, and the Sydney Harbour Trust Fund, towards the services of the Year 1947-1948. [Assented to, 30th September, 1947.]

WHEREAS we Your Majesty's most dutiful and Preamble.

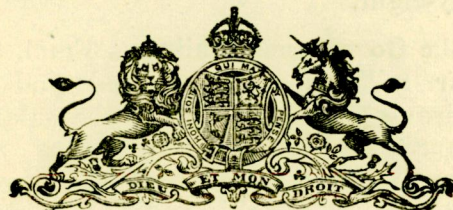

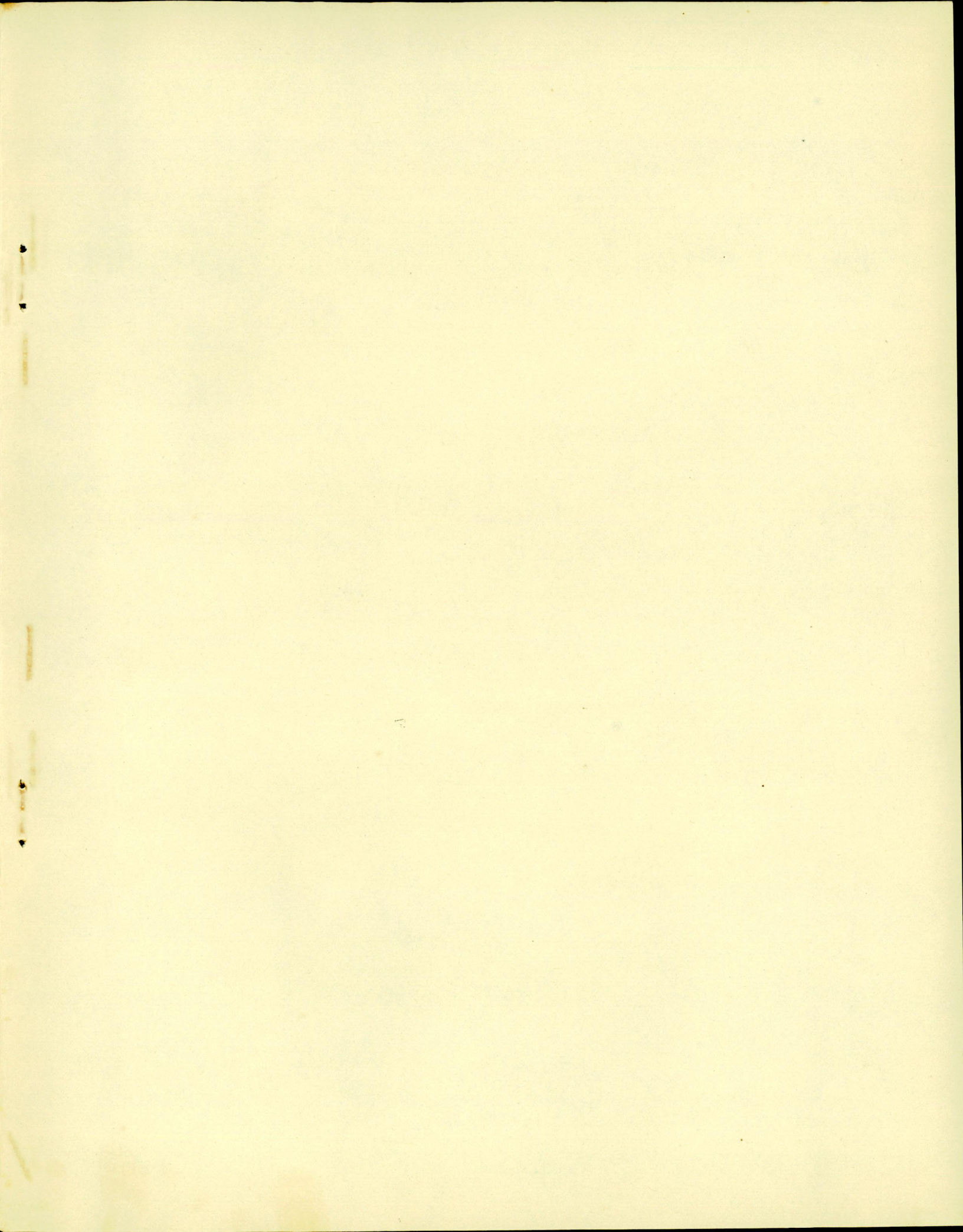
