BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

- 1. (1) This Act may be cited as the "Parliamentary Allowances and Salaries Act, 1951".
- (2) The Constitution Act, 1902, as amended by subsequent Acts, is in this Act referred to as the Principal Act.
- (3) This Act shall commence upon the first day of January, one thousand nine hundred and fifty-two.
