An Act to amend the Rural Workers Accommodation Act, 1926, in certain respects; and for purposes connected therewith.

[Assented to, 31st May, 1951.]

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- (c) The owner or person entitled to immediate possession of any accommodation may apply for a certificate of compliance as to the structural requirements of this Act and upon such application being made, an inspector shall within reasonable time inspect the accommodation and, if the accommodation complies with the structural requirements of this Act, shall give the applicant a certificate to that effect. action shall lie against any owner or person entitled to immediate possession for breach of any structural provisions of this Act in respect of any accommodation with regard to which such a certificate has been issued unless not less than three months' notice has been given to the owner or such person by the Department administering this Act of the structural alterations required to be made to bring the accommodation into compliance with the Act.

 - (ii) a member shall be eligible from time to time for re-appointment upon the expiration of his term of office.
- (e) Members shall be entitled to receive such remuneration or fees for their services as may be fixed from time to time by the Governor.




- (f) On the occurrence of a vacancy in the office of a member a person appointed to fill the vacant office shall, subject to this section, hold office for the remainder of the unexpired term of the vacant office.
- (g) In the case of illness or absence of a member, other than the chairman, the Governor may appoint a deputy to act in the place of such member during his illness or absence. Any deputy appointed under this paragraph whilst acting as such deputy shall have and may exercise all the powers, duties and functions of the member in whose place he acts.
- (h) The Governor may remove from office or suspend any member.
 - (3) The Committee shall have power to-
 - (a) investigate and make recommendations to the Minister in respect of special measures necessary for the proper accommodation of rural workers;

RURAL WORKERS ACCOMMODATION (AMENDMENT) BILL, 1951.

EXPLANATORY NOTE.

- (2) (a) The Committee shall consist of three members appointed by the Governor.
 - (b) Of the members so appointed-
 - (i) one member shall be nominated by the Minister to be chairman;
 - (ii) one member shall be representative of the persons required by this Act to provide accommodation for workers; and
 - (iii) one member shall be representative of rural workers.
- (c) If the chairman is unable to attend any meeting of the Committee he may appoint a person to attend and act for him
