

An Act to make provisions relating to certain Burragorang Valley cemeteries which will be inundated by the stored waters of Warragamba Dam; and for purposes connected therewith.

B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5 the same, as follows:-

Act No. 35, 1952.

An Act to make provisions relating to certain Burragorang Valley cemeteries which will be inundated by the stored waters of Warragamba Dam; and for purposes connected therewith. [Assented to, 29th October, 1952.]

B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Warragamba short Catchment Area Cemeteries Act, 1952." title.

Warragamba Catchment Area Cemeteries.

Vesting of certain cemeteries in Metropolitan Water Sewerage and Drainage Board. 2. (1) The lands described in Parts I, II, III and IV of the Schedule to this Act are hereby vested in the Metropolitan Water Sewerage and Drainage Board for an estate in fee simple for the purposes of the Metropolitan Water, Sewerage, and Drainage Act, 1924-1949.

(2) Any estate or interest in the said lands respectively described in Parts I, II, III and IV of the Schedule to this Act which immediately before the commencement of this Act was vested in or held by any persons or body of persons is hereby divested and all such persons and bodies are hereby discharged from any duties, liabilities or obligations existing immediately before the commencement of this Act in respect of or in relation to the said lands respectively.

(3) Any trusts, conditions, encumbrances or dedications affecting any of the said lands immediately before the commencement of this Act are hereby revoked and annulled.

Removal of human remains, headstones, etc. **3.** (1) Subject to the provisions hereinafter contained the said Board may cause the remains of all persons buried in the said lands (so far as such remains can by reasonable diligence be discovered or identified) together with all headstones, grave enclosures and other surface structures on such lands to be collected with due care and removed from such lands and shall cause any such remains so removed to be reverently reinterred and such headstones, grave enclosures and other surface structures to be re-erected in such cemetery as the Board may determine.

(2) The cost of such removal, reinterment and re-erection shall be borne by the said Board.

(3) At least one month before the remains of any person or any headstones, grave enclosures or other surface structures are removed under subsection one of this section an advertisement of the intention to remove the same shall be published three times at intervals of not less than two weeks in newspapers circulating in the locality and in one or more newspapers circulating in the Metropolitan Area. (4) At any time after publication of the first advertisement referred to in subsection three of this section and before the expiration of one month from publication of the last of such advertisements the representatives or any persons claiming to be the representatives of any person buried in any of the said lands may, at their own expense, remove the headstone, grave enclosure or other surface structure erected over the grave of such person and may, at their own expense, and with the permission of the Director-General of Public Health, remove the remains of such person to such cemetery as they may desire.

4. The said Board shall as soon as practicable after Register 4. The said Board shall as soon as practiculate data to be the commencement of this Act and before the removal to be compiled. of the remains of any person from any of the said lands compile with respect to each of the said lands a separate register of the names and other relevant information in respect of the persons buried therein, so far as such names and information can by reasonable diligence be obtained, and shall deposit such registers relating to the lands described in Parts I and II of the Schedule to this Act with the Church of England Property Trust Diocese of Sydney and such registers relating to the lands described in Parts III and IV of the Schedule to this Act with the trustees of the Roman Catholic Church for the Archdiocese of Sydney.

5. The said Board may do all such other things as it Power of Board. may consider necessary to carry fully into effect the purposes of this Act.
