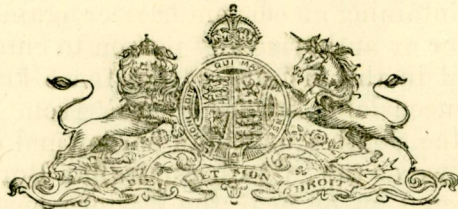

Act No. 35, 1950.

An Act to amend the Wild Dog Destruction Act, 1921, in certain respects; and for purposes connected therewith. [Assented to, 14th November, 1950.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** (1) This Act may be cited as the "Wild Dog Destruction (Amendment) Act, 1950." Short title and citation.

(2) The Wild Dog Destruction Act, 1921, as amended by subsequent Acts and by this Act, may be cited as the Wild Dog Destruction Act, 1921-1950.

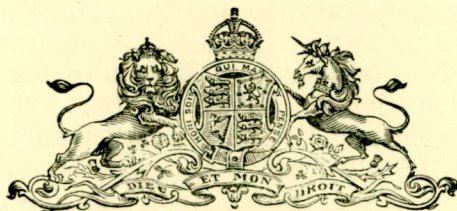
